On page 7, strike beginning with "**THE**" in line 3 down through "**PROGRAM**" in line 6 and substitute "<u>**THE SECRETARY MAY REQUIRE AN APPLICANT TO PROVIDE**</u> <u>**MATCHING FUNDS OR IN-KIND CONTRIBUTIONS AS A CONDITION OF RECEIVING**</u> <u>**A GRANT UNDER THIS SECTION**"; after line 12, insert:</u>
