AMENDMENTS TO HOUSE BILL 778

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 5, strike "a home or commercial building" and substitute "certain residential or commercial properties".

AMENDMENT NO. 2

On page 2, in line 7, after "HOME" insert ", RENTAL DWELLING UNIT,"; in line 8, strike "IN THE HOME OR COMMERCIAL BUILDING"; in lines 19 and 20, strike "AN INDIVIDUAL HOMEOWNER OR A SMALL BUSINESS" and substitute "A QUALIFIED TAXPAYER"; in line 22, strike "THE INDIVIDUAL IN THE INDIVIDUAL'S HOME" and substitute "AN INDIVIDUAL HOMEOWNER OR A LESSEE OF A RENTAL DWELLING UNIT"; in line 23, strike "THE" and substitute "A"; after line 23, insert:

"(6) "QUALIFIED TAXPAYER" MEANS:

- (I) AN INDIVIDUAL HOMEOWNER;
- (II) AN OWNER OF A RENTAL DWELLING UNIT; OR
- (III) A SMALL BUSINESS.
- (7) "RENTAL DWELLING UNIT" MEANS A DWELLING UNIT IN A MULTIFAMILY RESIDENTIAL BUILDING WITH FEWER THAN FIVE DWELLING UNITS.";

in line 24, strike "(6)" and substitute "(8)"; and in lines 28 and 29, strike "AN INDIVIDUAL OR A SMALL BUSINESS" and substitute "A QUALIFIED TAXPAYER".

On page 3, in lines 7 and 8 and 14 and 15, in each instance, strike "AN INDIVIDUAL OR A SMALL BUSINESS" and substitute "A QUALIFIED TAXPAYER"; in line 20, strike "INDIVIDUAL" and substitute "QUALIFIED TAXPAYER"; in line 26, strike "INDIVIDUAL OR SMALL BUSINESS" and substitute "QUALIFIED TAXPAYER"; in line 27, strike "INDIVIDUAL'S OR SMALL BUSINESS'S" and substitute "QUALIFIED TAXPAYER'S"; and in line 31, strike "AN INDIVIDUAL" and substitute "A QUALIFIED TAXPAYER OTHER THAN A SMALL BUSINESS".
