AMENDMENTS TO HOUSE BILL 1052
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in lines 2, 3, 5, and 30, in each instance, strike the first comma and substitute “and”; in lines 2, 3, and 5, in each instance, strike “, and Motor Fuel”; in lines 9, 10, and 11, in each instance, strike the first comma and substitute “or”; and in the same lines, in each instance, strike “, or motor fuel”.

On page 2, in line 1, strike “, and motor fuel”; in line 4, after “government;” insert “authorizing the disclosure of tax information to the Commission;”; in lines 7, 26, and 31, in each instance, strike the first comma and substitute “and”; in the same lines, in each instance, strike “, and Motor Fuel”.

On page 3, strike beginning with “9–301” in line 8 down through “9–337” in line 9 and substitute “13–203(c)”.

AMENDMENT NO. 2

On page 5, in line 4, strike the first comma and substitute “AND”; and in the same line, strike “, **AND MOTOR FUEL**”.

On page 9, in line 20, strike the first comma and substitute “AND”; and in lines 20 and 21, strike “, **AND MOTOR FUEL**”.

On page 10, in line 1, strike the first comma and substitute “AND”; and in the same line, strike “, **AND MOTOR FUEL**”.

On page 20 in line 18, on page 33 in line 31, and on page 45 in line 8, in each instance, strike the first comma and substitute “AND”; and in the same lines, in each instance, strike “, **AND MOTOR FUEL**”.

On page 62, in line 11, after “the” insert “Alcohol and Tobacco”; in lines 20 and 29, in each instance, strike the first comma and substitute “and”; and in the same lines, in each instance, strike “, and Motor Fuel”.

On page 63, in lines 5, 27, 29, and 40, in each instance, strike the first comma and substitute “and”; in lines 5 and 29, in each instance, strike “, and Motor Fuel”; in lines 27 and 28, strike “, and Motor Fuel”; and in line 40, strike the second comma.

On page 64, in line 1, strike “and Motor Fuel”; in line 12, strike the first comma and substitute “and”; and in the same line, strike “, and Motor Fuel”.

AMENDMENT NO. 3

On page 10, in lines 9 and 11, in each instance, strike “**A REPRESENTATIVE OF THE**” and substitute “**KNOWLEDGEABLE AND EXPERIENCED IN**”; in lines 10 and 12, in each instance, strike “**COMMUNITY**” and substitute “**MATTERS**”; and in line 13, strike “**A REPRESENTATIVE OF**” and substitute “**KNOWLEDGEABLE AND EXPERIENCED IN**”.

On page 11, in line 27, strike the first comma and substitute “**OR**”.

On pages 11 and 12, strike beginning with the first comma in line 28 on page 11 down through “**ARTICLE**” in line 1 on page 12.

On page 12, in lines 4, 9, and 15, in each instance, strike the first comma and substitute “**OR**”; in lines 4 and 5, strike “, **OR MOTOR FUEL**”; strike beginning with the first comma in line 10 down through “**ARTICLE**” in line 11; and in line 15, strike “, **OR MOTOR FUEL**”.

On page 13, in line 18, strike “**AND**”; and after line 20, insert:

“(V) COMPARABLE TOPICS RELATING TO SMOKING, VAPING, TOBACCO, OTHER TOBACCO PRODUCTS, AND ELECTRONIC NICOTINE DELIVERY SYSTEMS; AND”.

On page 14, in line 1, strike the first comma and substitute “OR”; and in the same line, strike “, **OR MOTOR FUEL**”.

On page 15, in lines 25 and 26, in each instance, strike the first comma and substitute “OR”; and in the same lines, in each instance, strike “, **OR MOTOR FUEL**”.

On page 16, in line 1, after the semicolon insert “AND”; and strike beginning with the semicolon in line 3 down through “**ARTICLE**” in line 4.

On pages 51 through 62, strike in their entirety the lines beginning with line 14 on page 51 through line 10 on page 62 and substitute:

“13-203.

(c) Tax information may be disclosed to:

(1) an employee or officer of the State who, by reason of that employment or office, has the right to the tax information;

(2) another tax collector;

(3) the Maryland Tax Court;

(4) a legal representative of the State, to review the tax information about a taxpayer:

(i) who applies for review under this title;

(ii) who appeals from a determination under this title; or

(iii) against whom an action to recover tax or a penalty is pending or will be initiated under this title;

(5) any license issuing authority of the State required by State law to verify through the Comptroller that an applicant has paid all undisputed taxes and unemployment insurance contributions payable to the Comptroller or the Secretary of Labor, Licensing, and Regulation or that the applicant has provided for payment in a manner satisfactory to the unit responsible for collection;

(6) a local official as defined in § 13-925 of this title to the extent necessary to administer Subtitle 9, Part V of this title;

(7) a federal official as defined in § 13-930 of this title to the extent necessary to administer Subtitle 9, Part VI of this title;

(8) the Maryland Department of Health in accordance with the federal Children's Health Insurance Program Reauthorization Act of 2009; [and]

(9) the State Board of Individual Tax Preparers; AND

(10) THE ALCOHOL AND TOBACCO COMMISSION.

On page 63, in lines 3 and 7, in each instance, strike the first comma and substitute "and"; and in the same lines, in each instance, strike ", and motor fuel".
