AMENDMENTS TO HOUSE BILL 1234

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “Chair, Wicomico County Delegation” and substitute “Delegates Adams, Anderton, Hartman, Mautz, and Sample–Hughes”; and in line 5, after “circumstances;” insert “requiring the State Department of Education, in consultation with county boards of education and the Motor Vehicle Administration, to adopt certain regulations;”.

AMENDMENT NO. 2

On page 3, in line 15, after “(C)” insert “**(1)**”; in lines 20, 21, 22, 23, 24, 25, and 26, strike “**(1)**”, “**(2)**”, “**(3)**”, “**(4)**”, “**(5)**”, “**(6)**”, and “**(7)**”, respectively, and substitute “**(I)**”, “**(II)**”, “**(III)**”, “**(IV)**”, “**(V)**”, “**(VI)**”, and “**(VII)**”, respectively; in line 20, strike “**PRESCHOOL**” and substitute “**PRESCHOOL–AGE**”; in line 21, strike “**RECEIVING SPECIAL EDUCATION SERVICES**” and substitute “**WITH DISABILITIES**”; in line 24, strike “**INACCESSIBLE**” and substitute “**WITHOUT ACCESS**”; in line 25, after the semicolon insert “**OR**”; in line 26, strike “**OR**” and substitute a comma; strike beginning with the semicolon in line 27 down through “**BOARD**” in line 29 and substitute “**, OR OTHER EDUCATIONAL PROGRAMS BASED OFF THE SCHOOL CAMPUS.**”

(2) A COUNTY BOARD MAY PROVIDE TRANSPORTATION IN ACCORDANCE WITH THIS SUBSECTION TO A PARTICULAR STUDENT GROUP THAT IS NOT LISTED UNDER PARAGRAPH (1) OF THIS SUBSECTION THROUGH A WRITTEN DETERMINATION BY THE COUNTY BOARD.

(3) THE DEPARTMENT, IN CONSULTATION WITH COUNTY BOARDS AND THE MOTOR VEHICLE ADMINISTRATION, SHALL ADOPT REGULATIONS
