A BILL ENTITLED

1 AN ACT concerning

2 **Prince George's County - Alcoholic Beverages**
3 **(13th Alcoholic Beverages District)**
4 **PG 304-96**

5 FOR the purpose of adding the Prince George's County portion of the 13th Legislative
6 District to those jurisdictions in which the Board of License Commissioners of
7 Prince George's County may not issue any new beer, wine and liquor license that
8 has an off-sale privilege within, or transfer any additional beer, wine or liquor
9 license that has an off-sale privilege into the area; clarifying language; continuing
10 an abrogation provision and including these provisions within it; and generally
11 relating to alcoholic beverages in Prince George's County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That the Laws of Maryland read as follows:

19 **Article 2B - Alcoholic Beverages**

20 9-217.

21 (l) (1) The Board of License Commissioners may not issue any new beer, wine
22 or liquor licenses that have an off-sale privilege within, or transfer any additional beer,
23 wine or liquor licenses that have an off-sale privilege into the boundaries of the 13TH,
24 21st, 22nd, 24th, 25th, 26th, or 27th alcoholic beverages district:

25 (i) THE 13TH ALCOHOLIC BEVERAGES DISTRICT SHALL AT ALL
26 TIMES BE COTERMINOUS WITH THE PRINCE GEORGE'S COUNTY PORTION OF THE
27 13TH LEGISLATIVE DISTRICT, AS DETERMINED BY THE PRINCE GEORGE'S COUNTY
28 BOARD OF SUPERVISORS OF ELECTIONS. AS OF APRIL 7, 1994, THE PRINCE GEORGE'S
29 COUNTY PORTION OF THE 13TH ALCOHOLIC BEVERAGES DISTRICT CONSISTED OF:

1 1. PRINCE GEORGE'S COUNTY ELECTION DISTRICT 10,
2 PRECINCTS 2 THROUGH 4;

3 2. THAT PART OF PRINCE GEORGE'S COUNTY ELECTION
4 DISTRICT 10, PRECINCT 1 THAT CONSISTS OF CENSUS TRACT 8002.04, BLOCKS 109
5 THROUGH 113, 119, 121 THROUGH 123, AND 128, BEING GENERALLY NORTH OF
6 ENGLEMAN DRIVE AND BRIARWOOD DRIVE; AND

7 3. THAT PART OF PRINCE GEORGE'S COUNTY ELECTION
8 DISTRICT 10, PRECINCT 9 THAT CONSISTS OF THE FOLLOWING CENSUS TRACTS AND
9 BLOCKS:

10 A. CENSUS TRACT 8001.03, BLOCKS 210, 213, 214, 216, 221, 222A,
11 222B, AND 226; AND

12 B. CENSUS TRACT 8002.04, BLOCKS 101, 102, 103A THROUGH
13 103C, 104A, 105, 114, 115, 116A THROUGH 116C, 117, 118A, AND 118B, BEING THAT AREA
14 GENERALLY NORTH OF OLD STAGECOACH ROAD.

15 (II) The 21st alcoholic beverages district at all times shall be
16 coterminous with the 21st legislative district of Prince George's County, as determined by
17 the Prince George's County Board of Supervisors of Elections. As of April 7, 1994, the
18 21st alcoholic beverages district consisted of:

- 19 1. Election district 1;
- 20 2. Election district 10, precincts 1, 5, 6, 7, 8, and 11;
- 21 3. Election district 17, precincts 4, 10, 11, 13, 14, 15, and 16; and
- 22 4. Election district 21, precincts 1, 2, 4, 5, 10, 14, 15, and 17.

23 [(ii)] (III) The 22nd alcoholic beverages district at all times shall be
24 coterminous with the 22nd legislative district of Prince George's County, as determined
25 by the Prince George's County Board of Supervisors of Elections. As of April 7, 1994, the
26 22nd alcoholic beverages district consisted of:

- 27 1. Election district 2, precincts 3, 4, 5, 6, 8, 9, and 10;
- 28 2. Election district 16;
- 29 3. Election district 17, precincts 6, 7, 9, and 12;
- 30 4. Election district 19;
- 31 5. Election district 20, precincts 1, 2, 3, 6, 7, and 11; and
- 32 6. Election district 21, precincts 7, 9, and 12.

33 [(iii)] (IV) The 24th alcoholic beverages district at all times shall be
34 coterminous with the 24th legislative district of Prince George's County, as determined by
35 the Prince George's County Board of Supervisors of Elections. As of April 7, 1994, the
36 alcoholic beverages district consisted of:

- 37 1. Election district 2, precincts 1, 2, and 7;

- 1 2. Election district 6, precinct 3;
- 2 3. Election district 13, precincts 1, 2, 3, 5, 7, 8, 14, 15, and 16;
- 3 4. Election district 17, precincts 1, 2, 3, 5, and 8;
- 4 5. Election district 18, precincts 1, 2, 3, 4, 5, 7, 8, and 9; and
- 5 6. Election district 20, precincts 4 and 8.

6 [(iv)] (V) The 25th alcoholic beverages district at all times shall be
7 coterminous with the 25th legislative district of Prince George's County, as determined by
8 the Prince George's County Board of Supervisors of Elections. As of April 7, 1994, the
9 25th alcoholic beverages district consisted of:

- 10 1. Election district 6, precincts 1, 4, 5, 6, 7, 9, 10, 11, 12, 15, 16,
11 18, 19, 20, 21, and 22;
- 12 2. Election district 9, precincts 3 and 10;
- 13 3. Election district 13, precincts 4, 6, 9, 10, 11, 12, and 13; and
- 14 4. Election district 18, precinct 6.

15 [(v)] (VI) The 26th alcoholic beverages district at all times shall be
16 coterminous with the 26th legislative district of Prince George's County, as determined by
17 the Prince George's County Board of Supervisors of Elections. As of April 7, 1994, the
18 26th alcoholic beverages district consisted of:

- 19 1. Election district 5, precincts 2, 5, and 6;
- 20 2. Election district 6, precincts 2, 8, 13, 14, and 17;
- 21 3. Election district 9, precincts 2 and 5; and
- 22 4. Election district 12, precincts 1 through 14.

23 [(vi)] (VII) The 27th alcoholic beverages district at all times shall be
24 coterminous with the 27th legislative district of Prince George's County, as determined by
25 the Prince George's County Board of Supervisors of Elections. As of April 7, 1994, the
26 27th alcoholic beverages district consisted of:

- 27 1. Election district 3, precincts 1 and 3;
- 28 2. Election district 4, precinct 1;
- 29 3. Election district 5, precincts 1, 3, and 4;
- 30 4. Election district 8, precinct 1;
- 31 5. Election district 9, precincts 1, 4, 6, 7, 8, and 9;
- 32 6. Election district 11, precincts 1 and 2; and
- 33 7. Election district 15, precincts 1 through 3.

1 (2) The Prince George's County Board of License Commissioners may
2 approve the issuance or transfer of a license into the boundaries of the 13TH (THAT
3 PORTION LOCATED WITHIN THE COUNTY), 21st, 22nd, 24th, 25th, 26th, or 27th
4 alcoholic beverages district provided any off-sale privileges of the license are
5 permanently waived as long as the license remains within the boundaries of the district.

6 SECTION 2. AND BE IT FURTHER ENACTED, That the changes made by this
7 Act to Article 2B, § 9-217(l) of the Annotated Code of Maryland shall remain effective
8 until September 30, 1997 and, at the end of September 30, 1997, and with no further
9 action required by the General Assembly, the changes made by this Act to Article 2B, §
10 9-217(l) shall be abrogated and of no further force and effect.

11 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 October 1, 1996.
