3 **(Wine Tasting License)**

4 FOR the purpose of creating a wine sampling and tasting alcoholic beverages license in
5 Frederick County; providing for the license; and generally relating to wine sampling
6 and tasting licenses.

7 BY renumbering

8 Article 2B - Alcoholic Beverages
9 Section 8-405 through 8-408, respectively
10 to be Section 8-406 through 8-409, respectively

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That Section(s) 8-405 through 8-408, respectively, of Article 2B -
20 Alcoholic Beverages of the Annotated Code of Maryland be renumbered to be Section(s)
21 8-406 through 8-409, respectively.

22 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
23 read as follows:

1 **Article 2B - Alcoholic Beverages**

2 8-405.

3 (A) THIS SECTION APPLIES ONLY IN FREDERICK COUNTY.

4 (B) THERE IS A WINE TASTING (WT) LICENSE.

5 (C) THE ANNUAL LICENSE FEE IS \$150.

6 (D) APPLICATIONS FOR A WT LICENSE SHALL BE MADE ON FORMS SUPPLIED
7 BY THE BOARD OF LICENSE COMMISSIONERS. RENEWALS OF THE LICENSE MAY BE
8 MADE AT THE TIME THE REGULAR LICENSE IS RENEWED. A LICENSE MAY BE
9 GRANTED WITHOUT A HEARING. IF APPLICATION FOR A LICENSE IS DENIED, THE
10 APPLICANT MAY REQUEST A PUBLIC HEARING BEFORE THE BOARD.

11 (E) (1) A WT LICENSEE MAY NOT SERVE TO ANY PERSON FOR SAMPLING OR
12 TASTING PURPOSES MORE THAN ONE OUNCE FROM EACH BRAND. A MAXIMUM OF
13 SIX BOTTLES MAY BE OPENED AT ANY ONE TIME.

14 (2) A WINE SAMPLING OR TASTING EVENT MAY NOT BE HELD MORE
15 THAN 15 DAYS EACH LICENSING PERIOD.

16 (3) THE LICENSEE SHALL NOTIFY THE BOARD IN WRITING AT LEAST 5
17 DAYS PRIOR TO EACH EVENT.

18 (4) ONCE OPENED, EACH BOTTLE USED FOR THE WINE SAMPLING OR
19 TASTING EVENT SHALL BE MARKED THAT IT IS TO BE USED FOR THAT PURPOSE
20 ONLY.

21 (5) THE CONTENTS OF EACH BOTTLE MAY NOT BE MIXED WITH ANY
22 OTHER BOTTLE AND ALL BOTTLES SHALL BE DESTROYED ONCE THEY ARE EMPTY.

23 (F) A WT LICENSE IS FOR ON-PREMISES CONSUMPTION ONLY. WINE
24 SAMPLING OR TASTING MAY NOT BE CONDUCTED FROM A DRIVE-THROUGH
25 WINDOW.

26 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
27 October 1, 1996.
