AMENDMENTS TO HOUSE BILL NO. 343

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “Sexual” and substitute “Crimes Against Children and Sex”; in lines 4, 5, 7, 10, 13, 17, 19, and 23, in each instance, strike “sexual”; in line 5, strike the first “a” and substitute “an”; and in lines 13 and 19, strike “a” and substitute “an”; strike beginning with “authorizing” in line 17 down through “agencies” in line 18 and substitute “requiring the Department”; in line 19, after “organizations” insert “and persons under certain circumstances; allowing certain local law enforcement agencies to make certain disclosures; providing for the contents of certain registration statements”; in line 23, after “time;” insert “altering certain time periods;”; and in line 27, strike “sexual” and substitute “the registration of”.

AMENDMENT NO. 2

On page 3, in line 7, strike “SEXUAL”; in line 20, after “YEARS” insert “, PROVIDED THAT THE COURT ORDERS THE OFFENDER TO REGISTER UNDER THIS SECTION”.

AMENDMENT NO. 3

Strike “sexual” in each of the following instances:

- on page 4, in lines 5, 8, 11, 14, 16, 19, 22, 25, 29, 30, 31, 32, 33, and 38;
- on page 5, in lines 1, 3, 7, 9, 28, and 29;
- on page 6, in lines 3, 5, 13, 34, and 36;
- on page 7, in lines 1, 3, 5, 7, 9, 11, 18, and 21;
- on page 8, in line 12;
- on page 9, in lines 9, 19, 32, and 33; and
- on page 10, in lines 1 and 8.

Strike “SEXUAL” in each of the following instances:

(Over)

on page 4, in line 26;
on page 5, in lines 13, 17, 21, and 30;
on page 6, in lines 6, 14, 18, 20, 22, 26, 27, 28, 30, and 33;
on page 7, in line 24;
on page 8, in line 10; and
on page 9, in lines 28 and 30.

On page 5, in lines 9 and 28, in each instance, strike the first “a” and substitute “AN”; and in line 29, strike the second “a” and substitute “AN”.

On page 6, in lines 3 and 18, in each instance, strike “A” and substitute “AN”; and in line 34, strike the second “a” and substitute “AN”.

On page 7, in line 24, strike “A” and substitute “AN”.

On page 9, in line 9, strike “a” and substitute “AN”; in line 19, strike “A” and substitute “AN”; in line 32, strike the first “a” and substitute “AN”; and in line 33, strike the second “a” and substitute “AN”.

On page 10, in line 1, strike “A” and substitute “AN”; and in line 8, strike “a” and substitute “AN”.

AMENDMENT NO. 4

On page 4, in line 18, strike “or”; and in line 20, after “convicted” insert “; OR”

(VII) IF THE OFFENDER IS IN THE STATE UNDER THE TERMS AND CONDITIONS OF THE INTERSTATE COMPACT AGREEMENTS UNDER ARTICLE 41, §§ 4-801 AND 4-1201 THROUGH 4-1211 OF THE CODE, THE SECRETARY OF PUBLIC SAFETY AND CORRECTIONAL SERVICES”.

On page 6, in line 24, strike “10” and substitute “7”.

AMENDMENT NO. 5

On page 7, in line 13, after “than” strike “3” and substitute “5”; and in line 23, strike “3” and substitute “5”.

On page 8, in line 10, after “RESIDE” insert “AND, IF APPLICABLE, A MUNICIPAL”

POLICE FORCE"; in line 19, strike "OR a local law enforcement agency may" and substitute "SHALL"; in line 20, strike "the following organizations" and substitute "ANY PERSON OR ORGANIZATION THAT THE DEPARTMENT DETERMINES MAY SERVE TO PROTECT THE PUBLIC CONCERNING A SPECIFIC OFFENDER"; in lines 20 and 21, strike "OR the agency"; strike beginning with "interest" in line 21 down through "youth" in line 24; after line 24, insert:

"(4) IN ADDITION TO THE DEPARTMENT, A LOCAL LAW ENFORCEMENT AGENCY MAY ALSO MAKE THE DISCLOSURES REQUIRED UNDER THIS SUBSECTION.";

in line 25, strike "(4)" and substitute "(5)(I)"; after line 28, insert:

"(II) A LOCAL LAW ENFORCEMENT AGENCY AND THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES MAY NOT RELEASE THE IDENTITY OF A VICTIM OF AN OFFENSE THAT REQUIRES REGISTRATION UNDER THIS SECTION.

(6) A DISCLOSURE UNDER THIS SUBSECTION MAY NOT BE CONSTRUED TO LIMIT OR PROHIBIT ANY OTHER DISCLOSURE PERMITTED OR REQUIRED UNDER LAW.

(7) (I) EXCEPT FOR A REGISTRATION STATEMENT PROVIDED TO A LAW ENFORCEMENT AGENCY, A REGISTRATION STATEMENT PROVIDED TO A PERSON OR ORGANIZATION UNDER THIS SECTION SHALL INCLUDE THE COMPLETED REGISTRATION FORM AND A COPY OF A PHOTOGRAPH OF THE OFFENDER, BUT NEED NOT INCLUDE THE OFFENDER'S FINGERPRINTS.

(II) THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES SHALL PROVIDE A LOCAL LAW ENFORCEMENT AGENCY WITH THE COMPLETED REGISTRATION FORM AND THE OFFENDER'S PHOTOGRAPH AND FINGERPRINTS.";

and in line 29, strike “(5)” and substitute “(8)”.

On page 9, in line 12, strike “3” and substitute “5”; in lines 26 and 29, strike “(I)” and “(II)”, respectively, and substitute “(1)” and “(2)”, respectively.
