AMENDMENT NO. 1

On page 1, in lines 5 and 12, in each instance, after “care” insert “or transportation”.

AMENDMENT NO. 2

On page 2, in line 27, after “CARE” insert “OR TRANSPORTATION”; in the same line, after “MEANS” insert “;

(I)”;

in line 29, after “EMPLOYED” insert “; OR

(II) TRANSPORTATION EXPENSES THAT ARE INCURRED BY A BUSINESS ENTITY TO ENABLE A QUALIFIED EMPLOYEE WITH A DISABILITY TO TRAVEL TO AND FROM WORK”.

On page 3, in line 16, after “CARE” insert “OR TRANSPORTATION”; in line 31, after “DISABILITY,” insert “OR TRANSPORTATION EXPENSES THAT ARE INCURRED BY A BUSINESS ENTITY TO ENABLE A QUALIFIED EMPLOYEE WITH A DISABILITY TO TRAVEL TO AND FROM WORK, A”; and in lines 32 and 35, in each instance, after “CARE” insert “OR TRANSPORTATION”.

On page 4, in line 34, after “CARE” insert “OR TRANSPORTATION”.

On page 5, in lines 16, 23, and 29, in each instance, after “FOR” insert “;

(1)”;

(Over)

in lines 17, 24, and 30, in each instance, strike “AND FOR” and substitute “; AND (2)(I)”; in line 19, after “ARTICLE” insert “; OR

(II) TRANSPORTATION PROVIDED OR PAID FOR BY THE INSURER FOR A QUALIFIED EMPLOYEE WITH A DISABILITY AS PROVIDED UNDER § 21-309 OF THE EDUCATION ARTICLE”;

in line 26, after “ARTICLE” insert “; OR

(II) TRANSPORTATION PROVIDED OR PAID FOR BY THE BUSINESS ENTITY FOR A QUALIFIED EMPLOYEE WITH A DISABILITY AS PROVIDED UNDER § 21-309 OF THE EDUCATION ARTICLE”;

in line 32, after “ARTICLE” insert “; OR

(II) TRANSPORTATION PROVIDED OR PAID FOR BY THE BUSINESS ENTITY FOR A QUALIFIED EMPLOYEE WITH A DISABILITY AS PROVIDED UNDER § 21-309 OF THE EDUCATION ARTICLE”.

On page 6, in lines 5 and 31, in each instance, after “CARE” insert “OR TRANSPORTATION”; in line 14, after “FOR” insert “;

(1)”;

in lines 14 and 15, strike “AND FOR” and substitute “; AND (2)(I)”; in line 17, after “ARTICLE” insert “; OR

(II) TRANSPORTATION PROVIDED OR PAID FOR BY THE BUSINESS ENTITY FOR A QUALIFIED EMPLOYEE WITH A DISABILITY AS PROVIDED UNDER § 21-309 OF THE EDUCATION ARTICLE”.
