5 FOR the purpose of making it a misdemeanor to violate certain WSSC emergency water
6 use restriction regulations; providing a certain penalty; and generally relating to
7 penalties for violations of WSSC emergency water use restriction regulations.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article 29 - Washington Suburban Sanitary District**

16 18-104.

17 (a) A person who violates any of the following provisions is guilty of a
18 misdemeanor and on conviction is subject to a fine not exceeding \$1,000 or imprisonment
19 not exceeding 30 days or both:

20 (1) Construction of private or municipal systems....§ 3-103(a)(3).

21 (2) Service connections.....§ 3-104.

22 (3) Control and disposition of surface waters....§§ 3-202 through 3-207.

23 (4) Bonds and anticipation notes.....§§ 4-101 through 4-112.

24 (5) WSSC rules and regulations (except for those specified in subsections (f)
25 [and], (g), AND (H) of this section).....§ 9-101.

26 (6) Public utilities construction.....§ 10-104.

27 (7) Flood control and navigation bonds.....§ 13-102.

1 (8) Tampering with WSSC system in Anne Arundel County....§ 14-103.

2 (9) Tampering with WSSC system in Howard County.....§ 15-105.

3 (10) Unlawful use of WSSC property, except for the rules and regulations
4 governing publicly owned watershed property.....§ 18-101.

5 (11) Leaving dead animals or fecal matter unburied.....§ 18-102.

6 (b) A person who violates §§ 11-101 through 11-117 (Merit System) of this article
7 is guilty of a misdemeanor and on conviction is subject to a fine not exceeding \$500.

8 (c) A person who violates § 3-206 of this article (special provisions applicable to
9 Takoma Park and Prince George's County, except the City of Bowie) is guilty of a
10 misdemeanor and on conviction is subject to a fine not exceeding \$500 or imprisonment
11 not exceeding 30 days or both.

12 (d) Any person who violates § 12-106 of this article (prohibited acts) is guilty of a
13 misdemeanor and on conviction is subject to a fine not exceeding \$1,000 or imprisonment
14 not exceeding 1 year or both.

15 (d-1) A person who violates § 3-109 of this article by committing a prohibited act
16 listed under § 14-308 of the State Finance and Procurement Article is, on conviction,
17 subject to the penalties provided under that section.

18 (e) A person may be convicted of a second or subsequent violation of any
19 provision of this article or any rule or regulation adopted under this article.

20 (f) A person who violates § 9-101 of this article (rules and regulations governing
21 publicly owned watershed property) has committed a WSSC infraction and shall pay to
22 the WSSC a civil fine as provided in § 18-104.1 of this article.

23 (g) A person who violates any of the following provisions has committed a WSSC
24 infraction and shall pay to the WSSC a civil monetary fine as provided in § 18-104.2 of
25 this article:

26 (1) Rules and regulations governing sewer cleaning..... § 3-301.

27 (2) Rules and regulations governing plumbing.....§ 8-101, § 8-102, § 8-103,
28 § 9-101, § 14-102, or § 15-104.

29 (3) Rules and regulations governing erosion and sediment control for utility
30 construction.....§ 9-101.

31 (4) Rules and regulations governing gasfitting.....§ 9-102.

32 (H) A PERSON WHO VIOLATES EMERGENCY WATER USE RESTRICTIONS
33 ADOPTED IN ACCORDANCE WITH § 9-101 OF THIS ARTICLE IS GUILTY OF A
34 MISDEMEANOR AND ON CONVICTION IS SUBJECT TO A FINE NOT EXCEEDING \$500
35 OR IMPRISONMENT NOT EXCEEDING 30 DAYS OR BOTH.

36 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
37 October 1, 1997.
