A BILL ENTITLED

1 AN ACT concerning

2 **Charles County - County Officials - Salaries and Expenses**

3 FOR the purpose of increasing the salaries of the Charles County Commissioners and the  
4 Charles County Treasurer beginning at a certain time; providing for the increase in  
5 expenses of the Charles County School Board Chairman at a certain time; providing  
6 that this Act does not apply to the salary or compensation of the incumbent  
7 members of the Charles County Commissioners or the Treasurer; and generally  
8 relating to the increase in salary and expenses for certain Charles County officials.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
20 MARYLAND, That the Laws of Maryland read as follows:

21 **Article 9 - Charles County**

22 27-2.

23 B. The salary of the President of the County Commissioners is:

24 (1) [\$38,100 for calendar year 1995; and

25 (2)] \$39,250 for calendar [year 1996] YEARS 1997 AND 1998; AND

26 (2) \$45,000 FOR CALENDAR YEAR 1999 and for each subsequent calendar  
27 year.

1 C. The salary for the other County Commissioners is:

2 (1) [\$28,840 for calendar year 1995; and

3 (2)] \$29,700 for calendar [year 1996] YEARS 1997 AND 1998; AND

4 (2) \$35,000 FOR CALENDAR YEAR 1999 and for each subsequent calendar  
5 year.

6 136-7.

7 A. The salary for the Treasurer is [\$36,050 for 1995 and] \$37,130 for [ each year  
8 thereafter] 1997 AND 1998 AND \$40,000 FOR EACH YEAR THEREAFTER.

9 **Article - Education**

10 4-107.

11 (f) (3) Each member of the county board of the counties specified in this  
12 paragraph shall receive the enumerated amounts annually for traveling and other  
13 expenses.

14 (iv) Charles County:

15 1. Member.....\$600;

16 2. Vice-chairman.....\$600; and

17 3. Chairman.....\$800 AND \$1,500 FOR  
18 CALENDAR YEAR 1999 AND EACH YEAR THEREAFTER.

19 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III,  
20 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or  
21 apply to the salary or compensation of the County Commissioners of Charles County or  
22 the Treasurer for Charles County in office on the effective date of this Act, but the  
23 provisions of this Act concerning the salary or compensation of the County  
24 Commissioners of Charles County or Treasurer of Charles County shall take effect at the  
25 beginning of the next following term of office.

26 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
27 October 1, 1997.
