AMENDMENTS TO SENATE BILL NO. 48

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 5, after "license;" insert "increasing the fee for certain licenses; establishing a 7-day Class D license;".

AMENDMENT NO. 2

On page 1, in line 16, after "4-101(g)," insert "6-401(g).".

AMENDMENT NO. 3

On page 2, in line 6, strike "23" and substitute "22"; and after line 6, insert:

"6-401.

(g) (1) This subsection applies only in Caroline County.

(2) The annual license fee is \$1,250 FOR A 6-DAY LICENSE.

(3) THE ANNUAL LICENSE FEE IS \$1,600 FOR A 7-DAY LICENSE.

[(3)] (4) All alcoholic beverages sold under this license must be consumed on the premises.

[(4)] (5) A licensee may sell beer, wine and liquor for consumption on the premises only."

AMENDMENT NO. 4

On page 2, strike beginning with "CLASS" in line 10 down through "LIQUOR" in line 11; and in line 11, after "LICENSEE" insert "WHO:

(Over)

(I) HOLDS ANY ALCOHOLIC BEVERAGES LICENSE ISSUED IN THE COUNTY;

(II) HOLDS A CATERER'S LICENSE ISSUED BY THE COUNTY HEALTH DEPARTMENT; AND

(III) CONTRACTS TO PROVIDE FOOD AND ALCOHOLIC BEVERAGES TO SPONSORS OF PUBLIC OR PRIVATE EVENTS”.

AMENDMENT NO. 5

On page 2, in line 13, strike “ANNUAL”; strike beginning with “PROVIDE” in line 15 down through “ATTACHED” in line 17 and substitute “KEEP FOR SALE AND SELL OR PROVIDE ALCOHOLIC BEVERAGES ON THE PREMISES OF AND DURING THE CATERED EVENT”.

AMENDMENT NO. 6

On pages 2 and 3, strike beginning with “fees” in line 35 on page 2 through “license” in line 3 on page 3 and substitute “FEE FOR EACH LICENSE IS \$50”.

AMENDMENT NO. 7

On page 3, in line 14, strike “are from 6 a.m.” and substitute “ON”; in line 15, strike “until” and substitute “ARE FROM 6 A.M. TO”; and in the same line, after “Sunday” insert “FOR A 6-DAY LICENSE HOLDER. FOR A 7-DAY LICENSE HOLDER THE HOURS ON MONDAY THROUGH SATURDAY ARE FROM 6 A.M. TO 2 A.M. THE FOLLOWING DAY (INCLUDING SUNDAY), AND ON SUNDAY, FROM 1 P.M. TO MIDNIGHT”.

AMENDMENT NO. 8

On page 4, in line 6, strike “6 A.M. TO 2 A.M.” and substitute “1 P.M. TO MIDNIGHT.”.
