A BILL ENTITLED

1 AN ACT concerning

2 **St. Mary's County - Salaries - County Commissioners, Sheriff, Treasurer,**
3 **and Orphans' Court Judges**

4 FOR the purpose of altering the salaries of the St. Mary's County Commissioners, the
5 salary of the Sheriff of St. Mary's County, the salary of the Treasurer of St.
6 Mary's County, and the salaries of the Orphans' Court judges in St. Mary's
7 County; providing that this Act does not apply to the salary or compensation of
8 the incumbent County Commissioners, Sheriff, Treasurer, and Orphans' Court
9 judges of St. Mary's County; and making a technical change.

2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
3 MARYLAND, That the Laws of Maryland read as follows:

4 **Article 25 - County Commissioners**

5 51.

6 (d) (1) The County Treasurer of St. Mary's County shall receive an annual
7 salary of [\$29,000] \$36,000.

8 (2) The County Treasurer shall devote full time to the duties of office.

9 **Article - Courts and Judicial Proceedings**

10 2-309.

11 (t) [(1) The salary of the Sheriff of St. Mary's County shall be \$31,000 for the
12 years 1989 and 1990.

13 (2) In 1991 the Sheriff's salary shall be \$48,000] THE SALARY OF THE
14 SHERIFF OF ST. MARY'S COUNTY SHALL BE \$50,000.

15 **Article - Estates and Trusts**

17 (s) Each of the judges of the Court for St. Mary's County shall receive an
18 annual salary of [\$2,400] \$3,000. Each judge shall also be allowed \$1,000 annually for
19 traveling expenses, payable quarterly.

22 A. Salaries.

23 (1) The President of the County Commissioners shall receive a salary of
24 [:

25 (a) \$24,000 for calendar year 1991;

26 (b) \$25,000 for calendar year 1992;

27 (c) \$26,000 for calendar year 1993; and

28 (d)] \$27,000 [for calendar year 1994 and for each subsequent
29 calendar year].

30 (2) Each other Commissioner shall receive a salary of [:

- 1 (a) \$18,000 for calendar year 1991;
2 (b) \$19,000 for calendar year 1992;
3 (c) \$20,000 for calendar year 1993; and
4 (d) \$21,000 for calendar year 1994 and for each subsequent
5 calendar year] \$25,000.

6 (3) The Attorney to the County Commissioners shall receive an annual
7 salary as determined by the Commissioners.

8 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III,
9 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or
10 apply to the salary or compensation of the County Commissioners, Sheriff, Treasurer,
11 or Orphans' Court judges in office on the effective date of this Act, but the provisions
12 of this Act concerning the salary or compensation of the County Commissioners,
13 Sheriff, Treasurer, or Orphans' Court judges shall take effect at the beginning of the
14 next following term of office.

15 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 October 1, 1998.
