2. IS MADE IN THE MANNER THAT IS CUSTOMARY FOR PERSONS IN THAT BUSINESS, EMPLOYMENT, OR PROFESSION; AND

3. <u>IS NOT FOR CONTINGENT COMPENSATION;</u>";

and in lines 16, 20, and 23, strike "(II)", "(III)", and "(IV)", respectively, and substitute "(III)", "(IV)", and "(V)", respectively.

On page 10, in line 16, after "DISTRICT;" insert "OR

<u>4.</u> FOR A MEMBER OF THE GENERAL ASSEMBLY, FOOD OR BEVERAGES RECEIVED AT THE TIME AND GEOGRAPHIC LOCATION OF A MEETING OF A LEGISLATIVE ORGANIZATION FOR WHICH THE MEMBER'S PRESIDING OFFICER HAS APPROVED THE MEMBER'S ATTENDANCE AT STATE EXPENSE;";

strike in their entirety lines 31 through 35, inclusive, and substitute:

"(VII) AS TO A MEMBER OF THE GENERAL ASSEMBLY,

REASONABLE EXPENSES FOR FOOD, TRAVEL, LODGING, OR SCHEDULED ENTERTAINMENT TO ATTEND A LEGISLATIVE CONFERENCE THAT HAS BEEN APPROVED BY THE MEMBER'S PRESIDING OFFICER;

(VIII) <u>TICKETS OR FREE ADMISSION EXTENDED TO AN ELECTED</u> <u>CONSTITUTIONAL OFFICER FROM THE PERSON SPONSORING OR CONDUCTING THE</u> <u>EVENT, AS A COURTESY OR CEREMONY TO THE OFFICE, TO ATTEND A CHARITABLE,</u> <u>CULTURAL, OR POLITICAL EVENT;</u>";

and in line 36, strike "(viii)" and substitute "(IX)".

On page 11, in lines 2 and 7, strike "(ix)" and "(x)", respectively, and substitute "(X)" and "(XI)", respectively.

On page 31, in line 14, after "GIFT" insert a colon; in line 15, before "FOOD" insert "<u>1</u>."; and in line 18, after "UNIT" insert "<u>;</u>

(III) NOTWITHSTANDING THE PROVISIONS OF SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE STATEMENT SHALL INCLUDE THE ACCEPTANCE OF EACH OF TWO OR MORE TICKETS OR FREE ADMISSIONS, EXTENDED TO A MEMBER OF THE GENERAL ASSEMBLY BY THE PERSON SPONSORING OR CONDUCTING THE EVENT, WITH A CUMULATIVE VALUE OF \$100 OR MORE RECEIVED FROM ONE ENTITY DURING THE APPLICABLE PERIOD". On page 34, in line 9, after "(vi)" insert "<u>1.</u>"; and in line 24, after the semicolon insert:

On page 35, in line 11, before the comma insert "<u>AND FOR EACH OF TWO OR MORE</u> <u>TICKETS OR FREE ADMISSIONS EXTENDED TO A MEMBER OF THE GENERAL</u> <u>ASSEMBLY WITH A CUMULATIVE VALUE OF \$100 OR MORE RECEIVED FROM ONE</u> <u>ENTITY DURING THE APPLICABLE PERIOD AS PROVIDED IN PARAGRAPH (2)(VI)2 OF</u> <u>THIS SUBSECTION</u>".

On page 36, in line 3, after "Legislative" insert a closing bracket; in the same line, strike the closing bracket; and in line 12, after "RECEPTIONS" insert "<u>AND TICKETS OR FREE</u> <u>ADMISSION</u>".
