AMENDMENTS TO HOUSE BILL NO. 831

(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 6, strike "members of"; strike beginning with "providing" in line 8 down through "exception;" in line 11; strike beginning with "Board" in line 13 down through "Education" in line 14 and substitute "School Superintendent"; strike beginning with the second "to" in line 14 down through "Council" in line 15; and strike beginning with "requiring" in line 19 down through "Panel;" in line 23 and substitute "requiring the County Board to provide the Management Oversight Panel with prior notification of certain proposed personnel and procurement actions;".

On page 2, strike beginning with "<u>authorizing</u>" in line 2 down through "<u>conditions</u>;" in line 4 and substitute "<u>requiring the Management Oversight Panel to submit annually to the General Assembly a certain report</u>;"; in line 9, strike "5-101(f),"; in the same line, strike "5-105,"; in line 15, strike "<u>3-1004(d) and 5-102(c)</u>" and substitute "<u>3-1004(d), 5-102(c), and 5-105</u>"; and strike in their entirety lines 18 through 22, inclusive.

AMENDMENT NO. 2

On page 2, after line 22, insert "Preamble

WHEREAS, The Prince George's County School Board has developed and approved a Master Plan that provides a long-range action plan to guide the Prince George's County Public School System in preparing students for successful citizenship in the twenty-first century; and

<u>WHEREAS</u>, The implementation of applicable MGT of America Performance Audit recommendations will facilitate the attainment of Master Plan priority goals; and

WHEREAS, The Prince George's County Management Oversight Panel and the Prince George's County School Board have established principles and protocols to facilitate the review and implementation of the recommendations of the MGT of America Performance Audit; now,

therefore,".

AMENDMENT NO. 3

On page 6, strike in their entirety lines 4 through 21, inclusive.

On page 7, strike beginning with "<u>PROVIDE</u>" in line 30 down through "<u>COMMITTEE</u>" in line 32, and substitute "<u>PARTICIPATE IN THE SEARCH PROCESS TO ENSURE THAT IMPLEMENTATION OF THE AUDIT RECOMMENDATIONS IS A KEY CRITERION IN THE SELECTION OF A NEW SUPERINTENDENT.</u>

(III) PRIOR TO BOARD OF EDUCATION APPROVAL OF SELECTION CRITERIA TO BE USED IN EVALUATION OF CANDIDATES FOR SUPERINTENDENT, THE MANAGEMENT OVERSIGHT PANEL SHALL RECEIVE A COPY OF THE PROPOSED CRITERIA AND MAKE RECOMMENDATIONS TO THE BOARD REGARDING HOW THE AUDIT RECOMMENDATIONS ARE ADDRESSED IN THE CRITERIA AND HOW PROSPECTIVE CANDIDATES SHOULD BE EVALUATED ON THIS ISSUE.

(IV) THE MANAGEMENT OVERSIGHT PANEL SHALL PROVIDE A BRIEF DESCRIPTION OF THE ROLE OF THE PANEL AND THE STATUS OF THE AUDIT RECOMMENDATIONS, WHICH SHALL BE INCLUDED IN THE MATERIALS PROVIDED TO PROSPECTIVE CANDIDATES FOR SUPERINTENDENT.

OF EDUCATION SHALL JOINTLY BRIEF THE FINAL CANDIDATES FOR SUPERINTENDENT ON THE ROLE OF THE MANAGEMENT OVERSIGHT PANEL AND THE AUDIT RECOMMENDATIONS AFTER THE BOARD SELECTS THE FINAL CANDIDATES AND PRIOR TO THE BOARD SELECTING A NEW SUPERINTENDENT".

AMENDMENT NO. 4

On page 8, strike beginning with "<u>EXCEPT</u>" in line 3 down through "(II)" in line 7; in line 8, strike "PRIOR TO" and substitute "<u>CONCURRENT WITH</u>"; in line 6, strike "AND"; in line 9, strike "BOARD." and substitute "<u>BOARD</u>; <u>AND</u>"; after line 9, insert:

"(II) SUBMIT SUPPLEMENTAL INFORMATION RELATING TO INFORMATION TECHNOLOGY EXPENDITURES BY STATE REPORTING CATEGORIES.";

strike in their entirety lines 10 through 26, inclusive.

On page 9, strike beginning with "EXCEPT" in line 23 down through "A" in line 24 and substitute "A".

On pages 9 and 10, strike in their entirety the lines beginning with line 30 on page 9 through line 4 on page 10, inclusive.

AMENDMENT NO. 5

On page 11, strike in their entirety lines 20 through 34, inclusive; in line 35, strike "(IV)" and substitute "(II)"; and in line 37 after "PERSONNEL" insert "ACTIONS RELATED TO SENIOR POSITIONS"; and in the same line, after "AND" insert "SUBSTANTIAL".

On page 12, after line 2, insert:

"(III) THE STATE SUPERINTENDENT OF SCHOOLS SHALL DETERMINE WHICH PERSONNEL AND PROCUREMENT ACTIONS MUST BE SUBMITTED TO THE MANAGEMENT OVERSIGHT PANEL AS PROVIDED BY SUBPARAGRAPH (II) OF THIS PARAGRAPH.";

in line 11, strike "11" and substitute "NINE"; strike beginning with the comma in line 14 down through "DELEGATION" in line 17; in line 22, strike the brackets; in line 24, strike the semicolon and substitute a period; and strike in their entirety lines 25 through 28, inclusive.

AMENDMENT NO. 6

On page 13, strike beginning with "FOR" in line 18 down through "RECOMMENDATIONS" in line 19; strike beginning with "BOARD," in line 21 down through "RECORD" in line 23, and substitute "BOARD TO DISCUSS ANY MATTER WHICH THE MANAGEMENT OVERSIGHT PANEL AND THE COUNTY BOARD MAY SEPARATELY DISCUSS IN EXECUTIVE SESSION".

On pages 13 and 14, strike in their entirety the lines beginning with line 39 on page 13 down through line 11 on page 14, inclusive.

On page 14, in line 12, strike "4." and substitute "2."; after line 14, insert:

"SECTION 3. AND BE IT FURTHER ENACTED, That the Management Oversight Panel annually shall submit to the General Assembly, in accordance with § 2-1246 of the State Government Article, a report on the activities of the Panel and its communications as established in § 5-206 of the Education Article.";

in line 15, strike "5." and substitute "4."; and in line 19, strike "6." and substitute "5.".
