- (5) for all projects exceeding \$500,000 in contract value, the University shall submit periodic status reports to the Department.
- [(e)] (D) For any public improvement project financed in whole or in part with proceeds of a consolidated capital bond loan or with State General Fund appropriations, the following additional procedures shall apply:
- (1) for architectural and engineering contracts exceeding \$100,000, the Department must request the Board of Public Works to authorize the transfer of the contract amount to University funds. Any additional funds that may be needed may be transferred by an action of the Board of Public Works upon review by the Department;
- (2) plans, specifications, schematics, design development, contract and bid documents shall be reviewed by the Department concurrent with University review;
  - (3) the Department may have a representative present at bid openings;
- (4) the University shall analyze construction bids, recommend contractor selections, and notify the Department of its recommended selection and the date the item will be on the Board of Public Works' agenda;
- (5) the Department shall prepare an agenda item for the Board of Public Works authorizing transfer to the University of the funds equal to the contract, plus 5% for use as a contingency fund for change orders. If the 5% contingency fund is insufficient to complete the project, the Department shall review the change conditions and make a recommendation to the Board of Public Works concerning the transfer of additional funds;
  - (6) all program changes not authorized in the original scope of the project shall be

approved by the Department of Budget and Management and the Department prior to commitment by the University;

- (7) at completion of the project, any unused amount of construction contingency funds or planning fund authorization shall be returned to the Board of Public Works by an action agenda item of the University; and
- (8) the Department shall be part of the final inspection of the project and final acceptance may not occur without the Department's concurrence.
- [(f)] (E) (1) For any public improvement project funded solely from funds other than State general funds or the proceeds of a general obligation bond loan, the University is responsible for procuring public improvement and public improvement-related services, for planning, and for management of all aspects of the project.
- (2) Any contract under this subsection is subject to approval by the Board of Public Works.".

- "(C) WITHIN 30 DAYS OF RECEIPT OF A NOTICE OF AN INSTITUTION'S INTENT TO ESTABLISH A NEW PROGRAM IN ACCORDANCE WITH SUBSECTION (A) OF THIS SECTION, THE COMMISSION MAY FILE, OR THE INSTITUTIONS OF HIGHER EDUCATION IN THE STATE MAY FILE WITH THE COMMISSION, AN OBJECTION TO IMPLEMENTATION OF A PROPOSED PROGRAM PROVIDED THE OBJECTION IS BASED ON:
- (1) INCONSISTENCY OF THE PROPOSED PROGRAM WITH THE INSTITUTION'S APPROVED MISSION;
- (2) UNREASONABLE PROGRAM DUPLICATION WHICH WOULD CAUSE DEMONSTRABLE HARM TO ANOTHER INSTITUTION; OR
- (3) VIOLATION OF THE STATE'S EQUAL EDUCATIONAL OPPORTUNITY OBLIGATIONS UNDER STATE AND FEDERAL LAW.
- (D) (1) IF AN OBJECTION IS FILED UNDER SUBSECTION (C) OF THIS SECTION BY THE COMMISSION OR AN INSTITUTION WITHIN 30 DAYS OF RECEIPT OF A NOTICE OF AN INSTITUTION'S INTENT TO ESTABLISH A NEW PROGRAM, THE COMMISSION SHALL IMMEDIATELY NOTIFY THE INSTITUTION'S GOVERNING BOARD AND PRESIDENT.
- (2) THE COMMISSION SHALL DETERMINE IF AN INSTITUTION'S OBJECTION IS JUSTIFIED BASED ON THE CRITERIA IN SUBSECTION (C) OF THIS SECTION.
  - (3) AN OBJECTION SHALL BE ACCOMPANIED BY DETAILED

INFORMATION SUPPORTING THE REASONS FOR THE OBJECTION.

- (4) IF THE COMMISSION DETERMINES THAT AN OBJECTION IS JUSTIFIED, THE COMMISSION SHALL NEGOTIATE WITH THE INSTITUTION'S GOVERNING BOARD AND PRESIDENT TO MODIFY THE PROPOSED PROGRAM IN ORDER TO RESOLVE THE OBJECTION.
- (5) <u>IF THE OBJECTION CANNOT BE RESOLVED WITHIN 30 DAYS OF</u>
  RECEIPT OF AN OBJECTION, THE COMMISSION SHALL MAKE A FINAL
  DETERMINATION ON APPROVAL OF THE NEW PROGRAM.";

and substitute "contingent on the taking effect of Chapter" (S.B. 129/H.B. 179) of the Acts of the General Assembly of 1999, the Board of Regents of the University System of Maryland shall establish and implement a collective bargaining plan, consistent with the principles and goals of Executive Order 01.01.1996.13, for the system's nonfaculty employees. The collective bargaining plan shall be developed and submitted to the Senate Budget and Taxation Committee, the Senate Finance Committee, and the House Appropriations Committee, on or before September 1, 1999. The committees shall have 30 days to review and comment on the plan, with the intent that the plan take effect on October 1, 1999. Two years after the implementation of the collective bargaining plan, the Board of Regents shall study the outcomes of the collective bargaining plan. The study shall assess the plan's effect on employee relations between nonfaculty employees and the University System of Maryland, and determine the fiscal impact of the plan on the University System of Maryland's operations. The Board of Regents shall report on or before December 1, 2001, subject to § 2-1246 of the State Government Article, to the Senate Budget and Taxation Committee, the Senate Finance Committee, and the House Appropriations Committee on the findings of the study. The committees shall evaluate the report's findings with the intent of possibly codifying the collective bargaining plan.".
