On page 1, in line 2, before "Public" insert "<u>Anne Arundel County -</u>"; strike beginning with "clarifying" in line 3 down through "subdivisions" in line 8 and substitute "<u>requiring custodians of</u> retirement records in Anne Arundel County to disclose certain information concerning that part of a pension or retirement allowance of certain retired elected or appointed officials of the county that is derived from employer contributions; requiring certain custodians of retirement records in the county to disclose certain information regarding employee contributions of certain retired or current officials of the county, if the officials consent to the disclosure; requiring custodians of retirement records in the county to maintain a list of officials of the county who consent to make certain information available"; and in line 9, after "disclosure" insert "<u>in Anne Arundel County</u>".

#### AMENDMENT NO. 2

On page 1, in line 20, strike "(6)" and substitute "(7)".

On page 2, in line 16, strike "TOTAL"; in the same line, strike "PENSION OR"; in line 20, strike "OR APPOINTED"; and after line 29, insert:
