AMENDMENTS TO SENATE BILL NO. 73

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 11, after “enactment;” insert “altering a certain reporting requirement;”; and in lines 12 and 13, strike “and sexual offenders” and substitute “sexual offenders, sexual offenders, sexually violent offenders, and sexually violent predators”.

On page 2, in line 2, strike “8, and 9” and substitute “and 8”; and after line 2, insert:

“BY repealing and reenacting, with amendments,
Chapter 754 of the Acts of the General Assembly of 1997
Section 9”.

AMENDMENT NO. 2

On page 4, in line 11, after “PREDATOR” insert “WHO IS REQUIRED TO REGISTER IN ANOTHER STATE;”; and in line 12, after the first “STATE” insert a comma.

AMENDMENT NO. 3

On page 9, in line 4, after “(1)” insert “SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION;”; in lines 6 and 7, strike “PLACE OF EMPLOYMENT;” and substitute a colon; after line 7, insert:

“1. FOR AN INDIVIDUAL WHO QUALIFIES AS A REGISTRANT UNDER SUBSECTION (A)(7)(VII)1 OF THIS SECTION, PLACE OF EMPLOYMENT; OR

2. FOR AN INDIVIDUAL WHO QUALIFIES AS A REGISTRANT UNDER SUBSECTION (A)(7)(VII)2 OF THIS SECTION, PLACE OF EDUCATIONAL INSTITUTION OR SCHOOL ENROLLMENT;”;

(Over)

after line 18, insert:

“(2) IF THE REGISTRANT IS A SEXUALLY VIOLENT PREDATOR, THE REGISTRATION STATEMENT SHALL ALSO INCLUDE:

(I) IDENTIFYING FACTORS, INCLUDING PHYSICAL DESCRIPTION;

(II) ANTICIPATED FUTURE RESIDENCE, IF KNOWN AT THE TIME OF REGISTRATION;

(III) OFFENSE HISTORY; AND

(IV) DOCUMENTATION OF TREATMENT RECEIVED FOR A MENTAL ABNORMALITY OR PERSONALITY DISORDER.”.

AMENDMENT NO. 4

On page 12, in lines 18 and 19, strike “AN INDIVIDUAL OR ORGANIZATION” and substitute “A PERSON”; and in line 24, strike “INDIVIDUAL, AGENCY, OR ENTITY” and substitute “PERSON”.

On page 13, in line 27, strike “INDIVIDUAL OR ORGANIZATION” and substitute “PERSON”.

AMENDMENT NO. 5

On page 15, in line 7, strike “Fiscal” and substitute “Legislative”.
