# AMENDMENTS TO SENATE BILL NO. 653 (First Reading File Bill)

### AMENDMENT NO. 1

On page 1, in line 4, after "benefits" insert "<u>or services</u>"; in line 7, after "circumstances;" insert "<u>specifying that a payor has no obligation to advise the injured person of the right to a certain reduction of a subrogation claim; requiring an injured person to provide a certain certification concerning attorney's fees incurred by the injured person under certain circumstances;"; and in line 9, after "benefits" insert "<u>or services</u>".</u>

### AMENDMENT NO. 2

On page 1, in line 22, after "(B)" insert "<u>(1) EXCEPT AS PROVIDED IN PARAGRAPH</u> (2) OF THIS SUBSECTION,"; in the same line, after "SUBROGATION" insert "<u>UNDER A</u> <u>CONTRACT OR APPLICABLE LAW</u>"; in line 23, after "BENEFITS" insert "<u>OR SERVICES</u>"; strike beginning with "UNDER" in line 24 down through "ARTICLE," in line 25; in line 25, after the first "OR" insert "<u>UNDER</u>"; and after line 29, insert:

# "(2) THIS SECTION DOES NOT APPLY TO A VOLUNTARY REDUCTION OF A SUBROGATION CLAIM BY A PAYOR THAT EXCEEDS THE REDUCTION OF THE SUBROGATION CLAIM DESCRIBED IN SUBSECTION (C) OF THIS SECTION.".

## AMENDMENT NO. 3

On page 2, strike beginning with "APPEARS" in line 1 down through "INJURY" in line 2 and substitute "<u>FILES A PETITION TO INTERVENE IN THE PERSONAL INJURY ACTION</u> <u>AND IS INDEPENDENTLY REPRESENTED BY COUNSEL</u>".

### AMENDMENT NO. 4

On page 2, in line 4, after "BENEFITS" insert "OR SERVICES".

## AMENDMENT NO. 5

On page 2, after line 14, insert:

"(D) A PAYOR HAS NO OBLIGATION TO ADVISE AN INJURED PERSON OR AN ATTORNEY FOR THE INJURED PERSON OF THE INJURED PERSON'S RIGHT TO A REDUCTION OF THE SUBROGATION CLAIM DESCRIBED IN SUBSECTION (C) OF THIS SECTION.

(E) ON WRITTEN REQUEST BY A PAYOR, AN INJURED PERSON OR AN ATTORNEY FOR THE INJURED PERSON WHO DEMANDS A REDUCTION OF THE SUBROGATION CLAIM DESCRIBED IN SUBSECTION (C) OF THIS SECTION SHALL PROVIDE THE PAYOR WITH A CERTIFICATION BY THE INJURED PERSON THAT STATES THE AMOUNT OF THE ATTORNEY'S FEES INCURRED BY THE INJURED PERSON FOR SERVICES RENDERED IN CONNECTION WITH THE INJURED PERSON'S CLAIM.".
