AMENDMENT NO. 2

On page 3, in line 13, after "DEVELOPED" insert "IN CONSULTATION WITH THE MUNICIPAL CORPORATIONS LOCATED WITHIN THE COUNTY".

AMENDMENT NO. 3

On page 3, in line 36, strike "QUALIFYING" and substitute "QUALIFIED"; on page 4, in line 1, strike "QUALIFYING" and substitute "QUALIFIED"; in line 10, strike "QUALIFYING" and substitute "A QUALIFIED"; and in the same line, strike "COUNTIES" and substitute "COUNTY".
