AMENDMENTS TO HOUSE BILL NO. 6

(Third Reading File Bill)

AMENDMENT NO. 1

On page 2, in line 22, strike “largely”.

On page 4, in line 25, after “(4)” insert “THE STATE SUPERINTENDENT OF SCHOOLS OR THE SUPERINTENDENT’S DESIGNEE;

(5)”;

in line 25, strike “EDUCATION” and substitute “HEALTH AND MENTAL HYGIENE”; in lines 27, 30, and 32, strike “(5)”, “(6)”, and “(7)”, respectively and substitute “(6)”, “(7)”, and “(8)”, respectively; and in line 32, strike “TWELVE” and substitute “FIFTEEN”.

On page 5, strike beginning with “AND” in line 2 down through “FUND” in line 3; in line 15, strike “THAT” and substitute “WHO”; in the same line, strike “AND”; in line 16, after “(VIII)” insert “ONE MEMBER OF A LOCAL MANAGEMENT BOARD;

(IX) ONE MEMBER OF A LOCAL BOARD OF EDUCATION;

(X) ONE MEMBER WHO IS A PROFESSIONAL IN THE FIELD OF RECREATION AND PARKS THAT DELIVERS LICENSED OR REGULATED CHILD CARE PROGRAMS; AND

(XI)”;

in line 26, strike “SECRETARY OF EDUCATION OR THE SECRETARY’S” and substitute “STATE SUPERINTENDENT OF SCHOOLS OR THE SUPERINTENDENT’S”; in line 29, strike “AND”; and in line 30, after “(V)” insert “THE SECRETARY OF HEALTH AND MENTAL

(Over)

HYGIENE OR THE SECRETARY'S DESIGNEE; AND
(VI)".

AMENDMENT NO. 2

On page 6, in line 34, after "(B)" insert "(1)".

On page 7, in lines 1, 2, and 3, strike "(1)", "(2)", and "(3)", respectively and substitute "(I)", "(II)", and "(III)", respectively; and after line 3, insert:

"(2) A MEMBER OF THE ADVISORY BOARD MAY NOT VOTE ON OR MAKE ANY RECOMMENDATION TO THE EXECUTIVE COMMITTEE IF THE MEMBER HAS A FINANCIAL INTEREST THAT MAY BE SUBSTANTIALLY AFFECTED BY THAT RECOMMENDATION."

On page 8, in line 5, after "(2)" insert "SUBJECT TO SUBSECTION (B) (2) OF THIS SECTION,".

AMENDMENT NO. 3

On page 8, in line 7, strike "AT LEAST FOUR" and substitute "A MAJORITY OF THE"; in line 11, strike "25%" and substitute "15%"; and in line 18, after "HAVE A" insert "POSITIVE".

AMENDMENT NO. 4

On page 10, in line 21, after "include" insert "\$10 million"; and strike beginning with "budget" in line 21, down through "million" in line 24, and substitute "budget for the Maryland After-School Opportunity Fund established under this Act, and that such funds shall be in addition to funds provided for child care and after-school programs in the fiscal year 2000 budget".
