1 AN ACT concerning

2 **Ethics Law - Use of Prestige of Office**

3 FOR the purpose of making applicable to all State officials the provision of the  
4 Maryland Public Ethics Law that prohibits the intentional use of the prestige of  
5 office or public position for the official's private gain or that of another, subject to  
6 an exception for the performance of usual and customary constituent services;  
7 providing for the application of this Act; and generally relating to standards of  
8 conduct under the Maryland Public Ethics Law; ~~and making this Act an~~  
9 ~~emergency measure.~~

6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
7 MARYLAND, That the Laws of Maryland read as follows:

8 **Article - State Government**

9 15-506.

10 (a) [A public] AN official or employee may not intentionally use the prestige of  
11 office or public position for that [public] official's or employee's private gain or that of  
12 another.

13 (b) The performance of usual and customary constituent services, without  
14 additional compensation, is not prohibited under subsection (a) of this section.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall supersede  
16 any amendment to § 15-506 of the State Government Article enacted under Chapter  
17 \_\_\_\_\_ (S.B. 1/H.B. 1) of the Acts of the General Assembly of 1999.

21 ~~SECTION 3. AND BE IT FURTHER ENACTED, That this Act is an emergency~~  
22 ~~measure, is necessary for the immediate preservation of the public health and safety,~~  
23 ~~has been passed by a yea and nay vote supported by three-fifths of all the members~~  
24 ~~elected to each of the two Houses of the General Assembly, and shall take effect from~~  
25 ~~the date it is enacted.~~

26 SECTION 2. 3. AND BE IT FURTHER ENACTED, That this Act shall take  
27 effect October 1, 1999.
