3 FOR the purpose of allowing reasonable attorney's fees for services rendered by

4 lawyers in certain unemployment benefits hearings; allowing certain claimants

5 to contest attorney's fees; authorizing the Board of Appeals of the Department of

6 Labor, Licensing, and Regulation to review certain attorney's fees; authorizing

7 the Board of Appeals to order a refund of certain attorney's fees under certain

8 circumstances; making stylistic changes; and generally relating to attorney's

9 fees in unemployment benefits hearings.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 16 MARYLAND, That the Laws of Maryland read as follows:

Article - Labor and Employment

19 (a) In a proceeding before a hearing examiner, special examiner, or the Board 20 of Appeals, a claimant may be represented by a lawyer or another agent authorized by 21 the claimant.

22 (b) (1) [An] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION,

23 AN agent may not charge or accept compensation for representing a claimant in a

24 proceeding before a hearing examiner, special examiner, or the Board of Appeals

25 [except that a lawyer may charge and accept compensation in an amount not greater

26 than that approved by the Board of Appeals].

HOUSE BILL 152

(2) A LAWYER MAY CHARGE AND ACCEPT REASONABLE ATTORNEY'S FEES FOR REPRESENTING A CLAIMANT IN A PROCEEDING BEFORE A HEARING EXAMINER, SPECIAL EXAMINER, OR THE BOARD OF APPEALS.

4 (3) ON APPLICATION OF A CLAIMANT, THE BOARD OF APPEALS MAY:

5 (I) HEAR AND DECIDE ANY QUESTION CONCERNING THE
6 REASONABLENESS OF FEES PAID FOR LEGAL SERVICES PERFORMED IN
7 CONNECTION WITH A CLAIM; AND

8 (II) ORDER A PERSON WHO RECEIVED A FEE FOR LEGAL SERVICES
9 TO REFUND TO THE PAYER ANY PART OF THE FEE THAT THE BOARD OF APPEALS
10 FINDS TO BE UNREASONABLE.

(c) In a proceeding before a hearing examiner, special examiner, or the Board
of Appeals, an employer may appear for itself or be represented by a lawyer or
another agent authorized by the employer.

14 (d) A person may not solicit, for that person or another person, the business of 15 appearing on behalf of a claimant in a proceeding before a hearing examiner, special 16 examiner, or the Board of Appeals.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 18 October 1, 1999.
