- 3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 4 MARYLAND, That the Laws of Maryland read as follows:

- 7 (A) BEGINNING IN FISCAL YEAR 2001, THERE SHALL BE INCLUDED IN THE
- 8 STATE BUDGET FOR THE JUDICIARY DEPARTMENT OF MARYLAND AN

- 32 during which a juror is required to be in attendance at or in proximity to the court in
- 33 which the juror has been called as a juror.
- 34 (b) A juror shall receive a State per diem amount of [\$5] \$15 each day the
- 35 juror attends court.

- 1 (c) The government of each county may supplement the State per diem 2 amount by local ordinance.
- 3 (d) There shall be included in the State budget for the Judiciary Department
- 4 of Maryland beginning in fiscal year [2000] 2001, an authorization to the
- 5 Administrative Office of the Courts in the total amount necessary to pay jurors the
- 6 State per diem amount.

## 7 SECTION 2. AND BE IT FURTHER ENACTED, That:

- 8 (1) Beginning in fiscal year 2001 and each fiscal year thereafter, each
- 9 county and Baltimore City shall use the local fiscal savings resulting from this Act to
- 10 increase local expenditures in one or more of the following categories:
- 11 (i) police officers and other law enforcement personnel; and
- 12 (ii) prosecutors in offices of the State's Attorney.
- 13 (2) Beginning in fiscal year 2001 through fiscal year 2008, each county
- 14 and Baltimore City shall report to the Department of Budget and Management on or
- $15\,$  before November 1 on the public safety expenditures to which the savings resulting
- 16 from this Act have been applied.
- 17 (3) Public safety expenditures required under this section shall be used
- 18 to supplement and may not supplant existing local expenditures for the same
- 19 purposes.
- 20 SECTION 3. AND BE IT FURTHER ENACTED, That the personnel
- 21 management and funding plans required under Sections 2-512 and 2-513 of the
- 22 Courts and Judicial Proceedings Article as enacted by Section 1 of this Act shall
- 23 account for individuals performing the functions identified in these sections on a
- 24 part-time basis.
- 25 SECTION 4. AND BE IT FURTHER ENACTED, That the county
- 26 reimbursement required under Sections 2-512 and 2-513 of this Act shall be based on
- 27 the State salary and benefit expenses that would have been paid to county employees
- 28 had they elected to become State employees.
- 29 SECTION 5. AND BE IT FURTHER ENACTED, That the State salary
- 30 schedules required under Sections 2-512 and 2-513 of this Act shall be based on
- 31 comparable salaries of State employees performing similar duties.
- 32 SECTION 6. AND BE IT FURTHER ENACTED, That developing the
- 33 personnel management plans required under Sections 2-512 and 2-513 of this Act,
- 34 the Administrative Office of the Courts shall, by no later than April 1, 2000, publish
- 35 a State salary and classification schedule for employees identified under these
- 36 sections.
- 37 SECTION 7. AND BE IT FURTHER ENACTED, That this Act shall take 38 effect July 1, 1999.
