- 14 (H) THE SALES AND USE TAX DOES NOT APPLY TO THE SALE THROUGH A
- 15 VENDING MACHINE OF MILK, BOTTLED WATER, FRESH FRUIT, FRESH VEGETABLES,

- 17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
