3 FOR the purpose of establishing the State Commission on the Capital City; providing

- 4 for the membership of the Commission; providing for the appointment, tenure,
- 5 and duties of members of the Commission; providing for the chairmanship of the
- 6 Commission; providing for the meeting times of the Commission; authorizing
- 7 the Commission to accept and give or spend certain moneys received from
- 8 certain sources; and generally relating to the State Commission on the Capital

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

17 MARYLAND, That the Laws of Maryland read as follows:

21 IN THIS SUBTITLE, "COMMISSION" MEANS THE STATE COMMISSION ON THE 22 CAPITAL CITY.

2 THERE IS A STATE COMMISSION ON THE CAPITAL CITY.

4 (A) THE COMMISSION CONSISTS OF:

5 (1) ONE INDIVIDUAL APPOINTED BY THE GOVERNOR; AND

6 (2) AS EX OFFICIO MEMBERS:

7 (I) THE GOVERNOR;

8 (II) THE STATE SENATOR WHO REPRESENTS THE DISTRICT IN 9 WHICH ANNAPOLIS IS LOCATED;

10 (III) THE COUNTY EXECUTIVE OF ANNE ARUNDEL COUNTY;

11 (IV) THE MAYOR OF ANNAPOLIS; AND

12 (V) THE SUPERINTENDENT OF THE UNITED STATES NAVAL 13 ACADEMY.

14 (B) (1) THE TERM OF THE APPOINTED MEMBER IS 4 YEARS.

15 (2) AT THE END OF A TERM, THE APPOINTED MEMBER CONTINUES TO 16 SERVE UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.

(3) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES
 ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND
 QUALIFIES.

THE COMMISSION SHALL MEET AT A REGULAR TIME AND PLACE TO BEDETERMINED BY THE COMMISSION.

26 (A) (1) THE COMMISSION SHALL STUDY POSSIBLE WAYS TO PRESERVE AND
27 IMPROVE ANNAPOLIS AS THE CAPITAL OF THE STATE, WITH PARTICULAR EMPHASIS

1 (I) THE FACILITIES AND DEVELOPMENT OF ANNAPOLIS AND 2 ADJACENT AREAS; AND

10 IN ADDITION TO ANY POWERS SET FORTH ELSEWHERE, THE COMMISSION:

11 (1) MAY ACCEPT MONEY FROM A PRIVATE OR PUBLIC AGENCY FOR USE 12 IN CARRYING OUT THE POWERS AND DUTIES OF THE COMMISSION; AND

13 (2) FOR THAT PURPOSE, MAY GIVE THE MONEY TO A PRIVATE OR PUBLIC 14 AGENCY OR OTHERWISE SPEND THE MONEY.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 16 October 1, 1999.
