3 FOR the purpose of requiring a person to be licensed by the Social Services

- 4 Administration of the Department of Human Resources before the person may
- 5 operate a residential educational facility on or after a certain date; authorizing
- 6 the Department of Human Resources to adopt regulations relating to the
- 7 licensing of residential educational facilities; providing that a residential
- 8 educational facility may not be required to obtain a license from more than one
- 9 State agency; authorizing any State agency authorized to license residential

10 educational facilities to make certain cooperative arrangements with any other

11 State agency; providing for the construction and application of this Act; defining

12 a certain term; altering a certain term; and generally relating to licensing of

13 residential educational facilities.

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 25 MARYLAND, That the Laws of Maryland read as follows:

- 28 (a) In this subtitle the following words have the meanings indicated.

3 (c) "Child placement agency" has the meaning stated in § 5-301 of this title.

4 (d) "Day care provider" means the adult who has primary responsibility for 5 the operation of a family day care home.

6 (e) "Family day care" means the care given to a child under the age of 13 years 7 or to any developmentally disabled person under the age of 21 years of age, in place of 8 parental care for less than 24 hours a day, in a residence other than the child's 9 residence, for which the day care provider is paid.

10 (f) "Family day care home" means a residence in which family day care is 11 provided.

(g) "Foster care" means continuous 24-hour care and supportive services
provided for a minor child placed by a child placement agency in an approved family
home.

15 (h) "Group care" means continuous 24-hour care and supportive services16 provided for a minor child placed in a licensed group facility.

(i) "Kinship care" means continuous 24-hour care and supportive services
provided for a minor child placed by a child placement agency in the home of a
relative related by blood or marriage within the 5th degree of consanguinity or

4 (c) (1) By rule or regulation, the Department may delegate authority to local 5 departments and licensed child placement agencies to issue licenses or approve 6 applicants for licenses under this subtitle.

7 (2) Any rule or regulation adopted by the Department under this
8 subsection shall provide for an appeal to an administrative appellate authority from a
9 decision of a local department or licensed child placement agency.

10 (d) (1) A child placement agency, child care home, [or] child care institution,

11 OR RESIDENTIAL EDUCATIONAL FACILITY may not be required to obtain a license 12 from more than 1 State agency.

18 (A) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (B) OF THIS SECTION
19 AND SUBJECT TO SUBSECTION (C) OF THIS SECTION, ON OR AFTER JANUARY 1, 2000,
20 A PERSON SHALL BE LICENSED BY THE ADMINISTRATION BEFORE THE PERSON MAY
