BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 14 MARYLAND, That the Laws of Maryland read as follows: 15 **Article - State Personnel and Pensions** 16 24-401. 17 A member may retire with a normal service retirement allowance if: (a) 18 (1) on or before the date of retirement, the member: 19 has at least 25 years of eligibility service; or (i) 20 (ii) is at least 50 years old; and

1 Before approving the Secretary's order, the Board of Trustees shall (2)2 give the member at least 30 days' notice and an opportunity to be heard. Except for the Secretary of the State Police, a member shall retire with a 3 4 normal service retirement allowance not later than the first day of the month after 5 the member becomes 60 years old. On retirement under this section, a member is entitled to receive a normal 6 (d) 7 service retirement allowance that equals: one forty-fifth of the member's average final compensation (1) 9 multiplied by each year of the member's first 25 years of creditable service; and 10 (2)one-ninetieth of the member's average final compensation multiplied 11 by each year of creditable service in excess of 25 years. 12 (E) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, A RETIREE, OR A 13 BENEFICIARY OF A RETIREE, WHO RETIRES ON OR BEFORE JUNE 30, 1999 WITH A 14 SERVICE RETIREMENT ALLOWANCE, SHALL RECEIVE AN ANNUAL RETIREMENT 15 ALLOWANCE ADJUSTMENT AS OF JULY 1, 1999, AS FOLLOWS: FOR A RETIREE WHO HAS BEEN RETIRED NOT MORE THAN 5 16 (I) 17 YEARS, \$1,200; FOR A RETIREE WHO HAS BEEN RETIRED MORE THAN 5 YEARS 18 (II)19 BUT NOT MORE THAN 10 YEARS, \$1,500; FOR A RETIREE WHO HAS BEEN RETIRED MORE THAN 10 YEARS 20 (III)21 BUT NOT MORE THAN 15 YEARS, \$1,800; AND 22 (IV) FOR A RETIREE WHO HAS BEEN RETIRED MORE THAN 15 YEARS, 23 \$2,100. 24 EACH FISCAL YEAR, THE BOARD OF TRUSTEES SHALL INCREASE THE (2) 25 ADJUSTMENT RECEIVED BY THE RETIREE OR THE BENEFICIARY AS OF JULY 1, 1999, 26 BY MULTIPLYING THE ADJUSTMENT BY A FRACTION THAT HAS: AS ITS NUMERATOR, THE CONSUMER PRICE INDEX FOR THE (I) 28 CALENDAR YEAR ENDING DECEMBER 31 OF THE PRECEDING FISCAL YEAR; AND 29 AS ITS DENOMINATOR, THE CONSUMER PRICE INDEX FOR THE
