## A BILL ENTITLED

## 1 AN ACT concerning

## 2 **Dumping of Dredge Spoil - Prohibitions**

- 3 FOR the purpose of prohibiting a person from dumping, depositing, or scattering
- 4 certain material excavated or dredged from certain areas of the Chesapeake Bay
- 5 into or onto the area known as Site 104; prohibiting a person from dumping,
- 6 depositing, or scattering certain material excavated or dredged from certain
- 7 areas of the Chesapeake Bay into or onto certain areas of the Chesapeake Bay,
- 8 subject to a certain exception; and generally relating to prohibitions of dumping
- 9 dredge spoil into or onto Site 104 and other areas of the Chesapeake Bay.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 16 MARYLAND, That the Laws of Maryland read as follows:

- 19 (a) A person may not dump, deposit, or scatter in an unconfined manner spoil
- 20 from Baltimore Harbor into or onto any portion of the water or bottomland of the
- 21 Chesapeake Bay or of the tidewater portions of any of the Chesapeake Bay's
- 22 tributaries outside of Baltimore Harbor. However, the spoil may be redeposited in
- 23 contained areas approved by the Department.
- 24 (b) A person may not dump, deposit, or scatter in an unconfined manner
- 25 Baltimore County tributary spoil into or onto any portion of the water or bottomland
- 26 of the Chesapeake Bay or of the tidewater portions of any of the Chesapeake Bay's
- 27 tributaries within 5 miles of the Hart-Miller-Pleasure Island chain in Baltimore
- 28 County.

- 1 (c) A person may not dump, deposit, scatter, or release sewage sludge by any
- 2 means, including discharge from a sewer or pipe, into or onto any portion of the water
- 3 or bottomland of the Chesapeake Bay or of the tidewater portions of any of the
- 4 Chesapeake Bay's tributaries within 5 miles of the Hart-Miller-Pleasure Island
- 5 chain in Baltimore County.
- 6 (d) A person may not dump, deposit, or scatter any earth, rock, soil, waste
- 7 matter, muck, or other material excavated or dredged from the Chesapeake Bay or its
- 8 tidal tributaries into or onto the area of the bottomlands or waters of the Chesapeake
- 9 Bay known as the deep trough.
- 10 (E) A PERSON MAY NOT DUMP, DEPOSIT, OR SCATTER ANY EARTH, ROCK, SOIL,
- 11 WASTE MATTER, MUCK, OR OTHER MATERIAL EXCAVATED OR DREDGED FROM THE
- 12 CHESAPEAKE BAY OR ITS TIDAL TRIBUTARIES INTO OR ONTO THE AREA OF THE
- 13 BOTTOMLANDS OR WATERS OF THE CHESAPEAKE BAY KNOWN AS SITE 104.
- 14 (F) A PERSON MAY NOT DUMP, DEPOSIT, OR SCATTER ANY EARTH, ROCK, SOIL,
- 15 WASTE MATTER, MUCK, OR OTHER MATERIAL EXCAVATED OR DREDGED FROM THE
- 16 CHESAPEAKE BAY OR ITS TIDAL TRIBUTARIES INTO OR ONTO THE BOTTOMLANDS OR
- 17 WATERS OF THE CHESAPEAKE BAY, EXCEPT WITHIN A 5 MILE RADIUS OF POOLES
- 18 ISLAND.
- 19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 20 October 1, 1999.
