1 AN ACT concerning

2 Motor Vehicle Administration - Special Registration Plates

- 3 FOR the purpose of authorizing the Motor Vehicle Administration to issue special
- 4 registration plates to individuals with certain disabilities or language
- 5 impairment; requiring a licensed physician to certify that an individual has
- 6 certain conditions before the individual qualifies for the special registration
- 7 plates; providing for the design of the special registration plates; requiring
- 8 certain individuals to have certain identification available for inspection by a
- 9 police officer at certain times; providing that individuals with special
- 10 registration plates issued under this Act are not entitled to certain parking
- privileges; prohibiting certain misrepresentations; providing for a penalty for
- violations of this Act; requiring the Motor Vehicle Administration to administer
- the special registration plates program; and generally relating to special
- registration plates for individuals with disabilities.

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 21 MARYLAND, That the Laws of Maryland read as follows:
- 22 Article Transportation

- 24 (A) (1) THE OWNER OF ANY VEHICLE DESCRIBED IN PARAGRAPH (2) OF THIS
- 25 SUBSECTION MAY APPLY TO THE ADMINISTRATION FOR THE ASSIGNMENT TO THAT
- 26 VEHICLE OF A SPECIAL REGISTRATION NUMBER AND SPECIAL REGISTRATION
- 27 PLATES, IF THE APPLICANT IS AN INDIVIDUAL WITH:
- 28 (I) SENSORY DISABILITIES OF HEARING OR SPEECH; OR

- 1 (II) LANGUAGE IMPAIRMENTS.
- 2 (2) THIS SECTION APPLIES ONLY TO:
- 3 (I) A CLASS A (PASSENGER) VEHICLE;
- 4 (II) A CLASS D (MOTORCYCLE) VEHICLE;
- 5 (III) A CLASS M (MULTIPURPOSE) VEHICLE;
- 6 (IV) A CLASS E (TRUCK) VEHICLE WITH A 1 TON OR LESS
- 7 MANUFACTURER'S RATED CAPACITY; OR
- 8 (V) A CLASS H, CLASS I, OR CLASS J VEHICLE THAT IS SPECIALLY
- 9 EQUIPPED FOR THE TRANSPORTATION OF INDIVIDUALS WITH DISABILITIES AND IS
- 10 USED EXCLUSIVELY FOR THE TRANSPORTATION OF INDIVIDUALS WITH
- 11 DISABILITIES.
- 12 (B) SPECIAL REGISTRATION AND SPECIAL REGISTRATION PLATES MAY BE
- 13 ISSUED UNDER THIS SECTION ONLY IF A LICENSED PHYSICIAN CERTIFIES THAT THE
- 14 APPLICANT IS AN INDIVIDUAL WITH A DISABILITY DESCRIBED IN SUBSECTION (A)(1)
- 15 OF THIS SECTION.
- 16 (C) AN APPLICANT FOR RENEWAL OF SPECIAL REGISTRATION AND SPECIAL
- 17 REGISTRATION PLATES ISSUED UNDER THIS SECTION SHALL SUBMIT PROOF OF THE
- 18 DISABILITY TO THE ADMINISTRATION BEFORE THE ISSUANCE OF THE NEW
- 19 MULTIYEAR REGISTRATION PLATES AND BEFORE THE RENEWAL OF THE
- 20 REGISTRATION EVERY 4 YEARS THEREAFTER.
- 21 (D) EXCEPT AS PROVIDED UNDER §§ 13-951 AND 13-952 OF THIS TITLE, NO FEE
- 22 IN ADDITION TO THE ANNUAL REGISTRATION FEE OTHERWISE REQUIRED BY THIS
- 23 TITLE IS REQUIRED FOR SPECIAL REGISTRATION UNDER THIS SECTION.
- 24 (E) A SPECIAL REGISTRATION NUMBER ASSIGNED UNDER THIS SECTION
- 25 SHALL:
- 26 (1) CONSIST OF THE LETTERS, NUMERALS, OR BOTH THAT THE
- 27 ADMINISTRATION SPECIFIES; AND
- 28 (2) BE DISPLAYED ON SPECIAL REGISTRATION PLATES ISSUED FOR THE
- 29 VEHICLE.
- 30 (F) A PERSON FOR WHOM SPECIAL REGISTRATION PLATES ARE ISSUED
- 31 UNDER THIS SECTION IS NOT ENTITLED TO ANY PARKING PRIVILEGES AVAILABLE
- 32 UNDER § 13-616 OF THIS SUBTITLE.
- 33 (G) WHILE DRIVING THE MOTOR VEHICLE WITH THE SPECIAL REGISTRATION
- 34 PLATES, THE PERSON SHALL:
- 35 (1) HAVE IN THE PERSON'S POSSESSION THE APPLICATION FOR SPECIAL
- 36 REGISTRATION PLATES THAT WAS APPROVED BY THE ADMINISTRATION; AND

- 1 (2) MAKE THE APPLICATION FOR SPECIAL REGISTRATION PLATES
- 2 AVAILABLE UPON THE REQUEST OF A POLICE OFFICER, WHILE THE OFFICER IS
- 3 DISCHARGING THE OFFICIAL DUTIES OF A POLICE OFFICER.
- 4 (H) A PERSON MAY NOT COMMIT ANY FRAUD IN APPLYING FOR SPECIAL
- 5 REGISTRATION UNDER THIS SECTION.
- 6 (I) A PERSON MAY NOT COMMIT ANY FRAUD IN USING SPECIAL
- 7 REGISTRATION UNDER THIS SECTION.
- 8 (J) A PERSON MAY NOT MAKE ANY MISREPRESENTATION IN APPLYING FOR
- 9 SPECIAL REGISTRATION UNDER THIS SECTION.
- 10 (K) A PERSON MAY NOT MAKE ANY MISREPRESENTATION IN USING SPECIAL
- 11 REGISTRATION UNDER THIS SECTION.
- 12 (L) ANY PERSON WHO VIOLATES THE PROVISIONS OF THIS SECTION IS
- 13 GUILTY OF A MISDEMEANOR, IN ACCORDANCE WITH THE TERMS OF § 27-101 OF THIS
- 14 ARTICLE.
- 15 (M) THE ADMINISTRATION SHALL ADMINISTER THE SPECIAL REGISTRATION
- 16 PLATES PROGRAM IN ACCORDANCE WITH THE PROVISIONS OF THIS SECTION.
- 17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 18 October 1, 1999.
