BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 14 MARYLAND, That the Laws of Maryland read as follows: 15 **Article - Estates and Trusts** 16 7-304. 17 Unless the will provides otherwise, and subject to subsection (b) OF (a) (1) 18 THIS SECTION, all expenses incurred in connection with the settlement of an estate of 19 a decedent[, including debts, funeral expenses, the contribution of the estate to estate 20 taxes, and interest and penalties concerning estate taxes, family allowances, 21 compensation of attorneys and personal representatives, and court costs] shall be 22 charged against the principal of the estate INCLUDING: 23 (I) **DEBTS:** 24 (II)**FUNERAL EXPENSES:** THE CONTRIBUTION OF THE ESTATE TO ESTATE TAXES AND 25 (III) 26 INTEREST AND PENALTIES CONCERNING ESTATE TAXES;

- 14 (a) The personal representative shall give written notice to each creditor who
- 15 has filed a claim under § 8-104 which is still open and to all interested persons of a
- 16 claim, petition, or other request which could result, directly or indirectly, in the
- 17 payment of a debt, COMPENSATION FOR EXPENSES, commission, fee, or other
- 18 compensation to or for the benefit of the personal representative or the attorney for
- 19 the estate. The notice shall state the amount requested, and set forth in reasonable
- 20 detail the basis for the request. It shall also state that a request for hearing may be
- 21 made within 20 days after the notice is sent.
- 22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 23 October 1, 1999.
