16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 17 MARYLAND, That the Laws of Maryland read as follows:

1 Article - Health - General 2 19-404. 3 (a) The Department shall adopt rules and regulations that set standards for 4 the care, treatment, health, safety, welfare, and comfort of patients of home health 5 agencies. The rules and regulations shall provide for the licensing of home health 6 (b) 7 agencies and annual license renewal, and shall establish standards that require as a 8 minimum, that all home health agencies: 9 Within 10 days of acceptance of a patient for skilled care, make and (1) 10 record all reasonable efforts to contact a physician to obtain the signed order required under paragraph (2); That accept patients for skilled care do so only on the signed order of 12 (2) 13 a physician obtained within 28 days after acceptance; 14 (3) Adopt procedures for the administration of drugs and biologicals; Maintain clinical records on all patients accepted for skilled care; 15 (4) Establish patient care policies and personnel policies; 16 (5) 17 (6)Have services available at least 8 hours a day, 5 days a week, and 18 available on an emergency basis 24 hours a day, 7 days a week; 19 (7) Make service available to an individual in need within 24 hours of a 20 referral when stipulated by a physician's order; 21 Have a designated supervisor of patient care who is a full-time (8) 22 employee of the agency and is available at all times during operating hours and 23 additionally as needed; and 24 Have as the administrator of the agency a person who has at least 1 year of supervisory experience in hospital management, home health management, or 26 public health program management and who is: 27 (i) A licensed physician; 28 (ii) A registered nurse; or 29 (iii) A college graduate with a bachelor's degree in a health-related 30 field. 31 The rules and regulations may include provisions that: (c)
