24 (a) (1) To determine the weekly benefit amount to assign to a claimant in 25 the schedule of benefits in subsection (b) of this section, the line in the schedule of 6 benefits shall be located in which the high quarter wages in column (A) correspond to 7 wages that the claimant was paid for covered employment in the calendar quarter of 8 the claimant's base period in which those wages were highest.
(2) The claimant shall be assigned:

(i) the weekly benefit amount in column (B) of the schedule for

(ii) if the claimant is not eligible under § 8-802 of this subtitle for

33 that weekly benefit amount but was paid wages to qualify in 1 of the next 6 lower
