- 21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 22 MARYLAND, That the Laws of Maryland read as follows:

- 25 (A) IN THIS SECTION, "AUTHORIZED PRESCRIBER" HAS THE MEANING STATED
- 26 IN § 12-101 OF THE HEALTH OCCUPATIONS ARTICLE.
- 27 (B) THIS SECTION APPLIES TO:

- 1 (1) INSURERS AND NONPROFIT HEALTH SERVICE PLANS THAT PROVIDE 2 COVERAGE FOR PRESCRIPTION DRUGS UNDER HEALTH INSURANCE POLICIES OR
- 3 CONTRACTS THAT ARE ISSUED OR DELIVERED IN THE STATE; AND
- 4 (2) HEALTH MAINTENANCE ORGANIZATIONS THAT PROVIDE COVERAGE
- 5 FOR PRESCRIPTION DRUGS UNDER CONTRACTS THAT ARE ISSUED OR DELIVERED IN

- 7 (C) AN ENTITY SUBJECT TO THIS SECTION MAY NOT LIMIT OR EXCLUDE

- 10 (1) PRESCRIBES A PRESCRIPTION DRUG THAT IS NOT LISTED ON ANY

- 12 THE AUTHORIZED PRESCRIBER DETERMINES THAT THE DRUGS INCLUDED IN ANY
- 13 DRUG FORMULARY MAINTAINED BY THE ENTITY HAVE BEEN INEFFECTIVE IN
- 14 TREATING THE INSURED'S OR ENROLLEE'S MEDICAL CONDITION; OR
- 15 (2) CONTINUES TO PRESCRIBE A PRESCRIPTION DRUG THAT
- 16 PREVIOUSLY HAD BEEN APPROVED FOR COVERAGE BY THE ENTITY SUBJECT TO
