4 5 6 7 8 9 10	FOR the purpose of establishing the Maryland Learning Success Program; requiring local education agencies to submit certain plans and reports to the State Superintendent of Education; requiring the State Superintendent of Education to make certain grants to local education agencies; providing the conditions for awarding Maryland Learning Success Program grants; providing for certain reporting; defining certain terms; requiring the Governor to include funding in the budget to accomplish the purposes of this Act; and generally relating to grants for class size reduction assistance.

THE PURPOSE OF THE MARYLAND LEARNING SUCCESS PROGRAM IS TO 13 (C) 14 PROVIDE GRANTS THAT WILL ASSIST LOCAL EDUCATION AGENCIES TO REDUCE 15 CLASS SIZES FOR READING INSTRUCTION IN THE FIRST AND SECOND GRADES AND 16 MATHEMATICS INSTRUCTION IN THE SEVENTH GRADE. - 23 FOR PROVISIONALLY CERTIFIED TEACHERS.
- 24 (H) (1) ON OR BEFORE OCTOBER 1, IN 2001 AND EACH SUCCEEDING YEAR,
- 25 EACH LOCAL EDUCATION AGENCY SHALL SUBMIT A MARYLAND LEARNING SUCCESS
- 26 REPORT TO THE STATE SUPERINTENDENT.
- 27 (2) THE REPORT SHALL DESCRIBE THE LOCAL EDUCATION AGENCY'S
- 28 ACTUAL USE OF FUNDING FROM MARYLAND LEARNING SUCCESS GRANTS, FEDERAL
- 29 CLASS SIZE INITIATIVE GRANTS PROVIDED IN PUBLIC LAW 105-277, AND ANY OTHER
- 30 FEDERAL FUNDS PROVIDED SPECIFICALLY FOR THE PURPOSE OF INCREASING THE

- 32 (3) THE REPORT SHALL INCLUDE THE RESULTS OF THE PERFORMANCE
- 33 INDICATORS SPECIFIED IN THE LOCAL EDUCATION AGENCY'S MARYLAND LEARNING
- 34 SUCCESS PLAN.
- 35 (4) THE REPORT MAY PROPOSE CHANGES TO THE LOCAL EDUCATION
- 36 AGENCY'S MARYLAND LEARNING SUCCESS PLAN.
- 37 (5) THE REPORT SHALL INCLUDE ANY OTHER INFORMATION REQUIRED
- 38 BY GUIDELINES OR REGULATIONS ISSUED BY THE STATE BOARD.
- 39 (6) THE REPORT SHALL BE IN A FORM AND FORMAT SPECIFIED BY THE
- 40 STATE SUPERINTENDENT.

- 1 (I) ON OR BEFORE DECEMBER 31 OF EACH YEAR, THE SUPERINTENDENT 2 SHALL REPORT THE STATUS OF THE MARYLAND LEARNING SUCCESS PROGRAM TO
- 3 THE GOVERNOR AND THE GENERAL ASSEMBLY.
- 4 (J) FOR FISCAL YEAR 2001 AND EACH SUCCEEDING FISCAL YEAR, THE
