A BILL ENTITLED

1 AN ACT concerning

2 State Personnel - Grievance Procedures - Award of Attorney's Fees

- 3 FOR the purpose of providing that a grievant who prevails in a certain grievance
- 4 proceeding is entitled to reimbursement for certain attorney's fees from the unit
- 5 that employs the grievant; providing for the application of this Act; and
- 6 generally relating to the remedies available to grievants who prevail in
- 7 grievance proceedings.

- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 14 MARYLAND, That the Laws of Maryland read as follows:
- 15 Article State Personnel and Pensions
- 16 12-402.
- 17 (a) Except as provided [in subsection (b)] SUBSECTIONS (B) AND (C) of this
- 18 section, the remedies available to a grievant under this title are limited to the
- 19 restoration of the rights, pay, status, or benefits that the grievant otherwise would
- 20 have had if the contested policy, procedure, or regulation had been applied
- 21 appropriately as determined by the final decision maker.
- 22 (b) (1) A decision maker at Step Two or Step Three of the grievance
- 23 procedure may order an appointing authority to grant back pay.
- 24 (2) (i) In a reclassification grievance back pay may be awarded for a
- 25 period not exceeding 1 year before the grievance procedure was initiated.
- 26 (ii) A back pay order under this paragraph is in the discretion of the
- 27 Secretary and the Office of Administrative Hearings.

- 1 (3) Subject to the limitations in Title 14, Subtitle 2 of this article, an
- 2 appointing authority shall carry out a back pay order issued under this subsection.
- 3 (C) IN ADDITION TO ANY OTHER REMEDIES AVAILABLE TO A GRIEVANT
- 4 UNDER THIS TITLE, A GRIEVANT WHO PREVAILS IN A GRIEVANCE PROCEEDING
- $5\,$ SHALL BE ENTITLED TO REIMBURSEMENT FROM THE UNIT THAT EMPLOYS THE
- 6 GRIEVANT FOR REASONABLE ATTORNEY'S FEES INCURRED BY THE GRIEVANT IN
- 7 CONNECTION WITH THE GRIEVANCE PROCEEDING.
- 8 SECTION 2. AND BE IT FURTHER ENACTED. That this Act shall be
- 9 construed retroactively and shall be applied to and interpreted to affect any grievant
- 10 who is the prevailing party under a final decision issued on or after January 1, 1997
- 11 in any grievance proceeding brought under Title 12 of the State Personnel and
- 12 Pensions Article.
- 13 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take
- 14 effect July 1, 1999.
