AMENDMENT NO. 1

On page 1, in line 4, after "Corporation;" insert "<u>increasing the number of members on the</u> <u>Board for the Fund; increasing the number of Board members that must concur for the Board to act;</u> <u>prohibiting a member from serving more than two terms under certain circumstances; repealing the</u> <u>requirement that the board appoint an executive vice president;</u>"; in line 7, strike "<u>certain provisions</u>" and substitute "<u>a certain provision</u>"; in the same line, strike "<u>subject</u>" and substitute "<u>subjects</u>"; strike beginning with "requiring" in line 21 through "Administration" in line 22 and substitute "<u>requiring</u> the Fund to be examined in accordance with provisions of the Insurance Article relating to the examination of an insurer's affairs, transactions, accounts, records, and assets; requiring the Fund to be subject to certain regulatory provisions of the Insurance Article; prohibiting the Insurance Commissioner from taking a certain action except under certain circumstances; allowing the Insurance Commissioner to examine or review the Fund for compliance with certain laws; requiring the Insurance Commissioner to report to the Board on the results of a certain examination or review"; in line 23, strike "<u>meet</u>" and substitute "<u>meets</u>"; and in line 24, after "<u>corporation;</u>" insert "<u>providing</u> that a certain service does not count toward a certain term limitation;".

On page 2, strike line 3 in its entirety and substitute "<u>Section 10-101, 10-105, 10-110,</u> <u>10-112, 10-113(a), 10-118, 10-122, and 10-125</u>"; strike line 8 in its entirety and substitute "<u>Section</u> <u>10-119 and 10-124</u>"; and strike in their entirety lines 11 through 15.

On page 2, after line 18 insert:

On page 3, after line 19, insert:

(a) <u>The Board consists of [7] 9 members appointed by the Governor with the advice and consent of the Senate.</u>

(b) Each member shall be a citizen of the State.

(c) Before taking office, each appointee to the Board shall take the oath required by Article I, § 9 of the Maryland Constitution.

(d) (1) The term of a member is 5 years.

(2) The terms of members are staggered as required by the terms provided for members of the Board on October 1, 1991.

(3) At the end of a term, a member continues to serve until a successor is appointed and qualifies.

(4) <u>A member who is appointed after a term has begun serves only for the rest of</u> the term and until a successor is appointed and qualifies.

(5) (I) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS PARAGRAPH, A MEMBER MAY NOT SERVE FOR MORE THAN TWO TERMS PROVIDED THAT SERVICE FOR A PARTIAL TERM OF 1 YEAR OR LESS MAY NOT BE COUNTED TOWARD THE TWO-TERM LIMITATION.

(e) The Governor may remove a member for incompetence or misconduct.

AMENDMENT NO. 4

On page 7, after line 7, insert:

"SECTION 3. AND BE IT FURTHER ENACTED, That notwithstanding § 10-110(d)(5) of the Labor and Employment Article, as enacted under Section 1 of this Act, for any person who is a member of the Board on the effective date of this Act, the following service shall not be counted toward the two-term limitation:

(a) any service by the member prior to the effective date of this Act; and

(b) any service included in the term that is in effect for the member on the effective date of this Act.";

and in line 8, strike "<u>3.</u>" and substitute "<u>4.</u>".
