AMENDMENTS TO SENATE BILL NO. 865
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike "Terms and"; and strike beginning with "altering" in line 5 down through "inspector" in line 14 and substitute "establishing the position of executive director of the Board of License Commissioners for Prince George's County; establishing that the executive director reports to the Board; setting the annual salary of the executive director; eliminating the position of administrator of the Board".

AMENDMENT NO. 2

On page 2, in lines 15 and 17, in each instance, strike the bracket; in line 17, strike "1 YEAR"; after line 19, insert:

(5) (I) THERE IS AN EXECUTIVE DIRECTOR OF THE BOARD OF LICENSE COMMISSIONERS.

(II) THE EXECUTIVE DIRECTOR SHALL BE APPOINTED BY THE GOVERNOR WITH THE ADVICE AND CONSENT OF THE SENATE.

(III) THE EXECUTIVE DIRECTOR SHALL MEET THE STANDARDS SET BY THE PRINCE GEORGE'S COUNTY MERIT BOARD AND SHALL BE CERTIFIED BY THE PERSONNEL DIRECTOR AS MEETING THESE STANDARDS.

(IV) THE EXECUTIVE DIRECTOR IS ENTITLED TO THE PROVISIONS OF THE COUNTY MERIT SYSTEM.

(V) THE EXECUTIVE DIRECTOR SHALL REPORT TO THE BOARD.

(Over)

(VI) THE EXECUTIVE DIRECTOR SHALL RECEIVE AN ANNUAL SALARY OF \$56,500.”;

strike beginning with “(i)” in line 26 down through “(5)” in line 32; in line 33, in each instance, strike the bracket; and in the same line, strike “GOVERNOR OR THE GOVERNOR’S DESIGNEE”.

AMENDMENT NO. 3

On page 3, in lines 1 and 9, strike “(6)” and “(7)”, respectively, and substitute “(5)” and “(6)”, respectively; in line 3, strike “AND THE ADMINISTRATOR”; strike beginning with “The” in line 21 down through “(iv)” in line 23; in line 25, strike “or (iii)”; in line 28, in each instance, strike the bracket; in the same line, strike “GOVERNOR OR THE GOVERNOR’S DESIGNEE”; and in line 29, strike “an administrator, an attorney,” and substitute “AN ATTORNEY”.

AMENDMENT NO. 4

On page 4, in line 7, in each instance, strike the bracket; in lines 7 and 8, strike “CHIEF INSPECTOR OR DEPUTY CHIEF INSPECTOR”; and in lines 18 and 19, in each instance, strike the bracket.
