# AMENDMENT NO. 1

On page 1, strike beginning with "for" in line 7 down through "program" in line 8; in line 8, strike "local"; in line 9, strike "a certain term" and substitute "certain terms"; and in line 20, after "(A)" insert:

"(1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

<u>(2)</u>";

in line 20, strike "IN THIS SECTION,"; strike beginning with "AN" in line 20 down through "OBTAIN" in line 21 and substitute "<u>THE PROGRAM OPERATED BY THE DEPARTMENT WHICH PROVIDES GRANTS TO TRANSPORTATION PROVIDERS FOR JOB ACCESS PROJECTS.</u>

(3) "JOB ACCESS PROJECT" MEANS A PROGRAM TO PROVIDE";

in line 22, after "ACTIVITIES" insert "FOR LOW INCOME INDIVIDUALS THAT:

- (I) FACILITATES TRIPS TO AND FROM JOBS AND OTHER EMPLOYMENT RELATED ACTIVITIES SUCH AS CHILD CARE AND JOB SKILLS ENHANCEMENT;
- (II) <u>SERVES LOW INCOME WORKERS WITHIN A SPECIFIED</u> <u>SERVICE AREA;</u>
  - (III) IS NOT RESTRICTED TO CLIENTS OF SOCIAL SERVICE

# AGENCIES; AND

(IV) MAY PERMIT INDIVIDUALS OTHER THAN LOW INCOME WORKERS TO USE THE TRANSPORTATION SERVICES TO THE EXTENT EXCESS CAPACITY IS AVAILABLE";

and in line 27, strike "PROVISION OF".

On page 2, in line 1, strike "TRANSPORTATION FOR"; and in the same line, strike "SERVICE" and substitute "PROGRAM".

#### AMENDMENT NO. 2

On page 2, strike beginning with "WITH" in line 3 down through the first comma in line 4 and substitute "TO THE MAXIMUM EXTENT PRACTICABLE,"; strike beginning with "DISTRIBUTE" in line 5 down through "ELIGIBLE" in line 6 and substitute "MAKE GRANTS COMPRISED OF FUNDS PROVIDED UNDER SUBSECTION (B) OF THIS SECTION TO THOSE"; in line 6, after "THAT" insert ":

- (I) OPERATE A JOB ACCESS PROJECT;
- (II) MEET THE REQUIREMENTS OF THIS SECTION;

<u>(III)</u>";

in line 8, after "REQUIRES" insert "; AND

#### (IV) RECEIVE APPROVAL FROM THE SECRETARY";

strike beginning with "NO" in line 9 down through "OF" in line 10 and substitute "BEFORE APPROVING AN APPLICATION FROM A TRANSPORTATION PROVIDER, THE SECRETARY SHALL CONSULT WITH"; in line 11, strike beginning with "IN" through "THE" and substitute "IN DESIGNING A JOB ACCESS PROJECT, A"; in line 12, strike "PROVIDERS" and substitute "PROVIDER"; in the same line, after "THE" insert "TRANSPORTATION NEEDS OF"; in line 13, strike "THEIR" and substitute "ITS"; strike beginning with "OF" in line 14 down through "DEADLINE" in line 16 and substitute "FUNDS ARE NOT DISTRIBUTED AS PROVIDED IN SUBSECTION (C) OF THIS SECTION"; in line 17, strike "THE"; in line 19, strike "ELIGIBLE"; and strike beginning with "AS" in line 20 down through "NEEDED" in line 22 and substitute "IN AREAS OF THE STATE THAT MOST NEED ADDITIONAL FUNDS FOR JOB

## AMENDMENT NO. 3

On page 2, strike in their entirety, lines 23 through 32, inclusive, and substitute:

- "(F) (1) A TRANSPORTATION PROVIDER THAT RECEIVES ANY FUNDS FOR A CAPITAL EXPENDITURE UNDER THE JOB ACCESS PROGRAM SHALL EXPEND A MATCHING FUND OF AT LEAST 20% OF THE TOTAL COST OF THE PROPOSED CAPITAL EXPENDITURE.
- (2) A TRANSPORTATION PROVIDER THAT RECEIVES ANY FUNDS FOR OPERATING EXPENDITURES UNDER THE JOB ACCESS PROGRAM SHALL EXPEND A MATCHING FUND OF AT LEAST 25% OF THE TOTAL COST OF THE PROPOSED OPERATING EXPENDITURES.".

#### AMENDMENT NO. 4

On page 2, strike beginning with the first "THE" in line 33 down through "(I)" in line 36; in line 36, strike "ALL AMOUNTS" and substitute "ANY GRANTS"; in line 37, strike "TO IT"; strike beginning with the second "THE" in line 38 down through "SERVICE;" in line 39 and substitute "A JOB ACCESS PROJECT.".

#### AMENDMENT NO. 5

On page 3, in line 1, strike "(II)" and substitute "(2)"; in the same line, after "PROVIDER" insert "THAT RECEIVES A GRANT UNDER THIS SECTION"; in line 3, strike "ITS" and substitute "LOW INCOME"; in lines 3 and 4, strike "IN THE JOB ACCESS PROGRAM;" and substitute "IN THE PROPOSED SERVICE AREA."; in line 5, strike "(III)" and substitute "(3)"; in the same line, strike "EACH" and substitute "A"; in the same line, after "WITH" insert "OTHER"; in line 7, strike beginning with the first "THE" through "AND" and substitute "LOW INCOME WORKERS."; strike in their entirety lines 8 through 19, inclusive; in line 22, strike beginning with "A" through "FUNDS" and substitute "ANY FUNDS PROVIDED"; strike beginning with "MAY" in line 23 down through "SERVICE" in line 24 and substitute "SHALL BE USED TO SUPPLEMENT AND SHALL NOT SUPPLANT EXISTING FUNDS USED BY A TRANSPORTATION PROVIDER FOR TRANSPORTATION SERVICES"; strike beginning with "WORKERS" in line

26 down through "PROGRAM" in line 27 and substitute "<u>LOW INCOME WORKERS</u>"; in line 27, strike "BY THE STATE"; in line 28, strike "EACH" and substitute "<u>A</u>"; in line 31, strike "THE" and substitute "<u>A</u>"; in the same line, strike "PROGRAM" and substitute "<u>PROJECT</u>"; in line 33, strike "RESOURCE" and substitute "<u>TRANSPORTATION</u>"; in line 34, strike "PROHIBITS" and substitute "SHALL BE CONSTRUED TO PROHIBIT".

# AMENDMENT NO. 6

On page 4, in line 3, strike "INDIVIDUALS IN THE JOB ACCESS PROGRAM" and substitute "LOW INCOME INDIVIDUALS"; and after line 7, insert:

"(M) THE SECRETARY SHALL ADOPT ANY REGULATIONS NECESSARY TO CARRY OUT THE PROVISIONS OF THIS SECTION.".
