AMENDMENTS TO SENATE BILL NO. 816 (First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 5, strike the second "a" and substitute "<u>an adult</u>"; in line 6, after "the" insert "<u>fiduciary</u>"; in line 7, after "circumstances;" insert "<u>providing that a report filed under this Act</u> shall be deemed to protect against or prevent certain illegal or unauthorized actions or other liability; providing that a fiduciary institution or an officer, employee, agent, or director of a fiduciary institution may decline to provide certain information about a report authorized under this Act under certain circumstances;"; in line 8, after "against" insert ", and there shall be certain immunity for,"; and in line 10, after "circumstances;" insert "providing that this Act does not create a certain duty on the part of a fiduciary institution or an officer, employee, agent, or director of a fiduciary institution; defining certain terms;".

AMENDMENT NO. 2

On page 1, after line 21 insert:

"(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

(2) <u>"FINANCIAL EXPLOITATION" MEANS ANY ACTION WHICH</u> INVOLVES THE MISUSE OF AN ADULT CUSTOMER'S FUNDS OR PROPERTY.

(3) <u>"REPORT" MEANS AN ORAL OR WRITTEN REPORT CONCERNING</u> FINANCIAL EXPLOITATION WHICH MAY INCLUDE ALL OR PART OF THE INFORMATION DESCRIBED IN §14-302(D) OF THE FAMILY LAW ARTICLE.".

AMENDMENT NO. 3

On page 1, in line 22, strike "(A)" and substitute "<u>(B)</u>"; in line 24, after "RECORDS" insert "<u>AND ANY OTHER INFORMATION</u>"; in the same line, strike "A" and substitute "<u>AN ADULT</u>"; in line 25, after the first "THE" insert "<u>FIDUCIARY</u>"; in line 27, strike "HAS REASON TO

BELIEVE" and substitute "BELIEVES"; and in line 28, after "TO" insert "FINANCIAL".

On page 2, in line 1, after "DISCLOSURE" insert "<u>IN A REPORT</u>"; strike beginning with the second "IN" in line 2 down through "ARTICLE" in line 3; after line 3, insert:

"(C) (1) <u>A REPORT FILED BY A FIDUCIARY INSTITUTION OR AN OFFICER,</u> EMPLOYEE, AGENT, OR DIRECTOR OF A FIDUCIARY INSTITUTION PURSUANT TO THIS SECTION SHALL BE DEEMED TO PROTECT AGAINST OR PREVENT ACTUAL OR POTENTIAL FRAUD, UNAUTHORIZED TRANSACTIONS, OR OTHER LIABILITY.

(2) A FIDUCIARY INSTITUTION OR AN OFFICER, EMPLOYEE, AGENT, OR DIRECTOR OF A FIDUCIARY INSTITUTION MAY DECLINE TO PROVIDE TO ANY PERSON INFORMATION THAT WOULD DISCLOSE OR INDICATE WHETHER A REPORT HAS OR HAS NOT BEEN MADE UNDER THIS SECTION.";

in line 4, strike "(B)" and substitute "<u>(D)</u>"; in the same line, strike "AND" and substitute a comma; in line 5, after "AGAINST" insert "<u>, AND THERE SHALL BE IMMUNITY FROM ANY CIVIL AND</u> <u>CRIMINAL LIABILITY THAT WOULD OTHERWISE RESULT FOR</u>"; in line 9, strike "SUBSECTION (A) OF"; in the same line, strike "OR"; in line 11, strike "§ 14-302(C) OF THE FAMILY LAW ARTICLE" and substitute "<u>THIS SECTION</u>; OR

(3) <u>DECLINING TO PROVIDE INFORMATION AS DESCRIBED IN</u> <u>SUBSECTION (C)(2) OF THIS SECTION</u>";

in line 12, strike "(C)" and substitute " (\underline{E}) "; and in line 16, strike "§ 14-302(C) OF THE FAMILY LAW ARTICLE" and substitute "<u>THIS SECTION</u>".
