## 1 **Article - Education** 2 SUBTITLE 24. MARYLAND DENT-CARE PROGRAM. 3 18-2401. IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS (A) 5 INDICATED. "HIGHER EDUCATION LOAN" MEANS ANY LOAN FOR UNDERGRADUATE OR 6 (B) 7 GRADUATE STUDY LEADING TO PRACTICE AS A DENTIST THAT IS OBTAINED FOR 8 TUITION, EDUCATIONAL EXPENSES, OR LIVING EXPENSES FROM: (1) A COLLEGE OR UNIVERSITY, GOVERNMENT, OR COMMERCIAL 10 SOURCE; OR 11 AN ORGANIZATION, INSTITUTION, ASSOCIATION, SOCIETY, OR 12 CORPORATION THAT IS EXEMPT FROM TAXATION UNDER § 501(C)(3) OR (4) OF THE 13 INTERNAL REVENUE CODE OF 1986. 14 (C) "PROGRAM" MEANS THE MARYLAND DENT-CARE PROGRAM. 15 18-2402.
