- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 17 MARYLAND, That the Laws of Maryland read as follows:
- 18 Article State Personnel and Pensions
- 19 23-306.2.
- 20 (A) THIS SECTION APPLIES TO A MEMBER OF THE EMPLOYEES' PENSION
- 21 SYSTEM OR THE TEACHERS' PENSION SYSTEM WHO IS SUBJECT TO THE
- 22 CONTRIBUTORY PENSION BENEFIT UNDER SUBTITLE 2, PART II OF THIS TITLE.
- 23 (B) A MEMBER IS ENTITLED TO THE ELIGIBILITY SERVICE TO WHICH THE
- 24 MEMBER WAS ENTITLED BEFORE THE SEPARATION FROM EMPLOYMENT IF THE
- 25 MEMBER:
- 26 (1) SEPARATED FROM EMPLOYMENT ON OR BEFORE JUNE 30, 1998;

- 1 (2) BECOMES A MEMBER WHO IS SUBJECT TO THE CONTRIBUTORY 2 PENSION BENEFIT UNDER SUBTITLE 2, PART II OF THIS TITLE ON OR BEFORE JUNE 3 30, 2003; AND
- 4 (3) APPLIES FOR THE PRIOR ELIGIBILITY SERVICE CREDIT BY
  5 COMPLETING A CLAIM FOR THE SERVICE CREDIT AND FILING IT WITH THE BOARD OF
  6 TRUSTEES ON THE FORM THAT THE BOARD OF TRUSTEES PROVIDES.
- 7 (C) (1) A MEMBER SHALL RECEIVE ELIGIBILITY SERVICE CREDIT UNDER 8 THIS SECTION BY COMPLETING A CLAIM FOR THE SERVICE CREDIT AND FILING IT 9 WITH THE BOARD OF TRUSTEES ON THE FORM THAT THE BOARD OF TRUSTEES 10 PROVIDES AT ANY TIME BEFORE RETIREMENT.
- 11 (2) WHEN A MEMBER RECEIVES CREDIT FOR ELIGIBILITY SERVICE 12 UNDER SUBSECTION (B) OF THIS SECTION FROM ANOTHER SYSTEM, THE MEMBER 13 HAS NO FURTHER RIGHTS IN THE OTHER SYSTEM.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 15 July 1, 2000.
