14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

15 MARYLAND, That the Laws of Maryland read as follows:

## **Article - Natural Resources**

18 (A) IN THIS SECTION, "WATER RESPONSE" MEANS ACTIONS TAKEN BY THE
19 DEPARTMENT, THE DEPARTMENT OF STATE POLICE, OR ANY OTHER UNIT OF STATE
20 OR LOCAL GOVERNMENT THAT RELATE TO EMERGENCIES AND OTHER SITUATIONS
21 IN THE WATERS OF THE STATE, AS DEFINED IN § 8-101(G) OF THIS ARTICLE.

(B) THERE IS A DIRECTOR OF WATER RESPONSE UNDER THE NATURALRESOURCES POLICE FORCE.

24 (C) THE DIRECTOR OF WATER RESPONSE SHALL BE RESPONSIBLE FOR THE
25 IMPLEMENTATION AND OVERSIGHT OF ALL STATE WATER RESPONSE ACTIVITIES
26 PERFORMED BY THE DEPARTMENT, THE DEPARTMENT OF STATE POLICE, AND ANY
27 OTHER UNIT OF STATE OR LOCAL GOVERNMENT.

28 (D) THE DIRECTOR OF WATER RESPONSE SHALL:

1(1)COORDINATE STATE ON-SITE AND ADMINISTRATIVE ACTIVITIES2RELATING TO A WATER RESPONSE SITUATION;

3 (2) ESTABLISH A CENTRAL OFFICE TO ORGANIZE, IMPLEMENT, AND 4 OVERSEE A STATE RESPONSE TO A WATER RESPONSE SITUATION;

5 (3) DEVELOP AND IMPLEMENT STATE TRAINING FOR A WATER 6 RESPONSE SITUATION;

7 (4) CATALOGUE THE EQUIPMENT AND HUMAN RESOURCES AVAILABLE 8 FOR A WATER RESPONSE SITUATION; AND

9 (5) DEVELOP AND RECOMMEND TO THE SECRETARY AND THE 10 SECRETARY OF THE STATE POLICE WATER RESPONSE EQUIPMENT NEEDS AND 11 STANDARDS.

12 (E) THE SECRETARY MAY ADOPT REGULATIONS NECESSARY TO IMPLEMENT 13 THIS SECTION.

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 15 October 1, 2000.
