BE IT ENACTED BY THE GENERAL ASSEMBLY OF 16 17 MARYLAND, That the Laws of Maryland read as follows: 18 **Article - Insurance** 19 15-130. THIS SECTION APPLIES TO: 20 (A) (1) INSURERS AND NONPROFIT HEALTH SERVICE PLANS THAT 21 (I) 22 PROVIDE COVERAGE FOR PRESCRIPTION DRUGS AND DEVICES UNDER HEALTH 23 INSURANCE POLICIES, CONTRACTS, OR CERTIFICATES THAT ARE ISSUED OR 24 DELIVERED IN THE STATE: 25 (II)HEALTH MAINTENANCE ORGANIZATIONS THAT PROVIDE

26 COVERAGE FOR PRESCRIPTION DRUGS AND DEVICES UNDER POLICIES, CONTRACTS,

27 OR CERTIFICATES THAT ARE ISSUED OR DELIVERED IN THE STATE;

- 1 (III) MANAGED CARE ORGANIZATIONS AS DEFINED IN § 15-101 OF
- 2 THE HEALTH GENERAL ARTICLE THAT PROVIDE COVERAGE FOR PRESCRIPTION
- 3 DRUGS AND DEVICES UNDER POLICIES, CONTRACTS, OR CERTIFICATES THAT ARE

- 5 (IV) TO THE EXTENT CONSISTENT WITH THE FEDERAL EMPLOYEE
- 6 RETIREMENT INCOME SECURITY ACT OF 1974 (ERISA), THIS SECTION APPLIES TO AN
- 7 INSURER, NONPROFIT HEALTH SERVICE PLAN, OR HEALTH MAINTENANCE
- 8 ORGANIZATION THAT ACTS AS A THIRD PARTY ADMINISTRATOR.
- 9 (2) AN INSURER, NONPROFIT HEALTH SERVICE PLAN, HEALTH
- 10 MAINTENANCE ORGANIZATION, OR MANAGED CARE ORGANIZATION THAT PROVIDES
- 11 COVERAGE FOR PRESCRIPTION DRUGS AND DEVICES THROUGH A PHARMACY
- 12 BENEFIT MANAGER IS SUBJECT TO THE REQUIREMENTS OF THIS SECTION.
- 13 (B) EACH ENTITY SUBJECT TO THIS SECTION SHALL PROVIDE TO EACH OF ITS
- 14 INSUREDS OR ENROLLEES A PRESCRIPTION CARD OR PROOF OF INSURANCE USING
- 15 OTHER TECHNOLOGY CONTAINING UNIFORM PRESCRIPTION DRUG INFORMATION.
- 16 (C) THE UNIFORM PRESCRIPTION DRUG INFORMATION CARD, OR PROOF OF
- 17 INSURANCE USING OTHER TECHNOLOGY, SHALL BE IN THE FORMAT APPROVED BY
- 18 THE NATIONAL COUNCIL FOR PRESCRIPTION DRUG PROGRAMS AND SHALL INCLUDE
- 19 ALL OF THE REQUIRED AND CONDITIONAL OR SITUATIONAL FIELDS AND CONFORM
- 20 TO THE MOST RECENT PHARMACY IDENTIFICATION CARD OR TECHNOLOGY
- 21 IMPLEMENTATION GUIDE PRODUCED BY THE NATIONAL COUNCIL FOR
- 22 PRESCRIPTION DRUG PROGRAMS OR CONFORM TO A NATIONAL FORMAT
- 23 ACCEPTABLE TO THE INSURANCE COMMISSIONER.
- 24 (D) A NEW PRESCRIPTION DRUG CARD, OR PROOF OF INSURANCE USING
- 25 OTHER TECHNOLOGY, SHALL BE ISSUED IN ACCORDANCE WITH SUBSECTION (B) OF
- 26 THIS SECTION UPON ENROLLMENT AND REISSUED UPON ANY CHANGE IN THE
- 27 INSURED'S OR ENROLLEE'S COVERAGE THAT IMPACTS ON THE DATA CONTAINED ON
- 28 THE CARD.
- 29 (E) THE COMMISSIONER IN CONSULTATION WITH THE BOARD OF PHARMACY
- 30 MAY ADOPT REGULATIONS NECESSARY TO CARRY OUT THIS SECTION.
- 31 (F) THIS ACT SHALL APPLY TO ALL POLICIES OR HEALTH BENEFIT PLANS
- 32 ISSUED, DELIVERED, OR RENEWED ON OR AFTER JANUARY 1, 2001.
- 33 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 34 October 1, 2000.
