3 FOR the purpose of establishing a statewide public information program on hepatitis

4 C education, prevention, and screening; providing for the development and

5 implementation of a public education and outreach program; providing for a

6 program to educate health care providers; providing for access to hepatitis C

7 information and patient referral services; providing for a certain program in

8 cooperation with the Department of Public Safety and Correctional Services;

9 providing for the investigation and development of reports for certain cases of

10 hepatitis C; providing for the evaluation and improvement of hepatitis C

11 support services in the community; requiring the Secretary of Health and

12 Mental Hygiene to submit certain reports to the Governor and the General

Assembly on its findings, recommendations, and activities; and generally

Preamble

22 WHEREAS, Hepatitis C is a silent killer largely asymptomatic until 23 irreversible liver damage occurs;

24 WHEREAS, Hepatitis C is characterized by the World Health Organization as 25 a disease of primary concern to humanity;

26 WHEREAS, Hepatitis C currently infects approximately 4.5 million Americans 27 and there are approximately 30,000 new infections each year in the United States;

WHEREAS, The Centers for Disease Control estimates that approximately 2 12,000 individuals die each year from the consequences of hepatitis C and this 3 number is expected to rise; WHEREAS, Approximately 90,000 citizens of Maryland are infected with 5 hepatitis C; WHEREAS, Since the disease is considered a serious public health threat, the 7 United States Department of Health and Human Services has launched a 8 comprehensive plan to address this significant health problem, beginning with the 9 identification and notification of hundreds of thousands of individuals who have been 10 exposed to hepatitis C through blood transfusions; and 11 WHEREAS, In the absence of a vaccine, emphasis must be placed on other 12 means of disease awareness and prevention, including education of police officers, 13 firefighters, health care providers, and the general public; now, therefore, SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 15 MARYLAND, That the Laws of Maryland read as follows: Article - Health - General 16 SUBTITLE 8. HEPATITIS C EDUCATION, PREVENTION, AND SCREENING ACT. 17 18 18-801. 19 THE SECRETARY SHALL ESTABLISH AND PROMOTE A STATEWIDE PUBLIC 20 INFORMATION PROGRAM ON HEPATITIS C EDUCATION, PREVENTION, AND 21 SCREENING. 22 18-802. 23 THE SECRETARY SHALL: DEVELOP AND IMPLEMENT A PUBLIC EDUCATION AND OUTREACH 24 (1)25 PROGRAM TO: (I) RAISE AWARENESS OF HEPATITIS C AIMED AT HIGH-RISK 26 27 POPULATIONS, PHYSICIANS' OFFICES, HEALTH CARE PROVIDERS, HEALTH CARE 28 FACILITIES, PUBLIC SAFETY PERSONNEL, AND CORRECTIONS OFFICERS; AND PROVIDE INFORMATION ON RISK FACTORS, THE VALUE OF 29 (II) 30 EARLY DETECTION, AND THE OPTIONS AVAILABLE FOR TREATMENT OF HEPATITIS C: DESIGN AND IMPLEMENT A PROGRAM TO EDUCATE HEALTH CARE 31 (2)32 PROVIDERS IN: 33 (I) THE EPIDEMIOLOGY, NATURAL HISTORY, DETECTION, AND 34 TREATMENT OF HEPATITIS C; AND

ON OR BEFORE DECEMBER 1 OF EACH YEAR, THE SECRETARY SHALL ISSUE A 24 REPORT TO THE GOVERNOR AND, SUBJECT TO § 2-1246 OF THE STATE GOVERNMENT 25 ARTICLE, THE GENERAL ASSEMBLY ON THE PROGRAM FINDINGS, 26 RECOMMENDATIONS, AND ACTIVITIES.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 28 October 1, 2000.
