2 Smart Growth - Visions - Adequate Public Facilities

- 3 FOR the purpose of adding a new vision relating to adequate public facilities and
- 4 infrastructure to the list of visions to be implemented by certain planning
- 5 commissions in the development and implementation of land use policy; adding
- to the State Growth, Resource Protection, and Planning Policy the policy of
- 7 having adequate public facilities and infrastructure available in certain growth
- 8 areas; providing for the prospective application of this Act; and generally
- 9 relating to Smart Growth, policy visions, and land use policy in the State.

- 25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 26 MARYLAND, That the Laws of Maryland read as follows:

- 3 (a) In the preparation of the plan the commission shall make careful and 4 comprehensive surveys and studies of present conditions and future growth of the jurisdiction, and with due regard to its relation to neighboring territory. The plan 6 shall be made with the general purpose of guiding and accomplishing the coordinated, 7 adjusted, and harmonious development of the jurisdiction, and its environs which 8 will, in accordance with present and future needs, best promote health, safety, morals, 9 order, convenience, prosperity, and general welfare, as well as efficiency and economy 10 in the process of development; including among other things, adequate provisions for 11 traffic, the promotion of public safety, adequate provision for light and air, 12 conservation of natural resources, the prevention of environmental pollution, the 13 promotion of the healthful and convenient distribution of population, the promotion of 14 good civic design and arrangement, wise and efficient expenditure of public funds, 15 and the adequate provision of public utilities and other public requirements. 16 In addition to the requirements of subsection (a) of this section, the (b)
- 16 (b) In addition to the requirements of subsection (a) of this section, the 17 commission shall implement the following visions through the plan described in § 18 3.05 of this article:
- 19 (1) Development is concentrated in suitable areas;
- 20 (2) Sensitive areas are protected;
- 21 (3) In rural areas, growth is directed to existing population centers and 22 resource areas are protected;
- 23 (4) Stewardship of the Chesapeake Bay and the land is a universal ethic;
- 24 (5) Conservation of resources, including a reduction in resource 25 consumption, is practiced;
- 26 (6) To assure the achievement of paragraphs (1) through (5) of this 27 subsection, economic growth is encouraged and regulatory mechanisms are
- 28 streamlined; [and]
- 29 (7) ADEQUATE PUBLIC FACILITIES AND INFRASTRUCTURE ARE 30 AVAILABLE OR PLANNED IN AREAS WHERE GROWTH IS TO OCCUR; AND
- 31 (8) Funding mechanisms are addressed to achieve these visions.
- 32 (c) (1) Except as provided in paragraph (2) of this subsection, the authority
- 33 to adopt regulations concerning the implementation of subsection (b) of this section in
- 34 a plan shall be vested solely in the legislative body of the jurisdiction that has adopted
- 35 the plan.
- 36 (2) This subsection does not limit the Office of Planning, the State

- 28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be
- 29 construed only prospectively and may not be applied or interpreted to have any effect
- 30 on or application to any local comprehensive plan, master plan, sector plan, or
- 31 implementing ordinance or policy, or to any State development policy, the
- 32 development, implementation, enactment, or amendment of which begins before the
- 33 effective date of this Act.

- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 2 October 1, 2000.
