- 20 beaver, mink, muskrat, otter, fox, skunk, fisher, and long-tailed weasel, or any part,

	(iv) The Department may extend any muskrat season set by this subsection for a period of 1 week, if the Department considers it necessary for any reason, including weather conditions.
32	(2) A person may possess the meat of muskrat or otter no more than 10 days after the close of open season for these mammals in order to dispose of the meat for food. However, a person may apply for a permit to store the meat during the closed season if the meat was hunted lawfully.
