12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

13 MARYLAND, That the Laws of Maryland read as follows:

16 (D) (1) (I) IN THIS SUBSECTION THE FOLLOWING WORDS HAVE THE 17 MEANINGS INDICATED.

18 (II) "TELECOMMUNICATIONS" MEANS THE TRANSMISSION OF
19 INFORMATION OF THE USER'S CHOOSING, BETWEEN OR AMONG POINTS SPECIFIED
20 BY THE USER, WITHOUT CHANGE IN THE CONTENT OF THE INFORMATION AS IT IS
21 SENT AND RECEIVED.

(III) 1. "TELECOMMUNICATIONS PROVIDER" MEANS A PROVIDER
OF TELECOMMUNICATIONS FOR A FEE TO THE PUBLIC OR TO CLASSES OF USERS
MAKING TELECOMMUNICATIONS AVAILABLE DIRECTLY TO THE PUBLIC,
REGARDLESS OF THE FACILITIES USED.

13."TELECOMMUNICATIONS PROVIDER" DOES NOT INCLUDE2A PROVIDER OF TELECOMMUNICATIONS PREDOMINANTLY FOR USE ONLY IN SINGLE3STRUCTURES SUCH AS HOTELS, OFFICE BUILDINGS, OR APARTMENT BUILDINGS.

4 (2) EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS SUBSECTION, THE
5 SALES AND USE TAX DOES NOT APPLY TO THE SALE TO OR USE BY A
6 TELECOMMUNICATIONS PROVIDER OF ANY MACHINERY OR EQUIPMENT, INCLUDING

(I) A TELECOMMUNICATIONS BUSINESS; OR

(II) AN INTERNET SERVICE BUSINESS THAT OFFERS OR PROVIDES
 SERVICE THROUGH THE USE OF THE COMPUTER AND TELECOMMUNICATIONS
 FACILITIES, INCLUDING EQUIPMENT AND OPERATING SOFTWARE, THAT COMPRISE
 THE INTERCONNECTED WORLDWIDE NETWORK OF NETWORKS THAT EMPLOY THE
 TRANSMISSION CONTROL PROTOCOL/INTERNET PROTOCOL, OR ANY PREDECESSOR
 OR SUCCESSOR PROTOCOLS TO THAT PROTOCOL.

17 (3) THE EXEMPTION UNDER THIS SUBSECTION DOES NOT APPLY TO
18 UPGRADES TO A SYSTEM THAT WAS NOT ORIGINALLY DESIGNED TO PROVIDE
19 TELECOMMUNICATIONS, INCLUDING A CABLE TELEVISION SYSTEM OR AN ELECTRIC
20 POWER DISTRIBUTION SYSTEM, UNLESS THE PURPOSE OF THE UPGRADE IS TO
21 ALLOW THE SYSTEM TO PROVIDE TELECOMMUNICATIONS OR TO MODIFY THE
22 TELECOMMUNICATIONS FUNCTIONS OF THE SYSTEM.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 24 July 1, 2000.
