- 1 (B) "CIGARETTE RESTITUTION FUND" MEANS THE FUND ESTABLISHED 2 UNDER § 7-317 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.
- 3 (C) "PROGRAM" MEANS THE ADULT AND ADOLESCENT SUBSTANCE ABUSE 4 TREATMENT AND SERVICES FOR MINORITY POPULATIONS PROGRAM.

- 6 (A) THERE IS THE ADULT AND ADOLESCENT SUBSTANCE ABUSE TREATMENT 7 AND SERVICES FOR MINORITY POPULATIONS PROGRAM WITHIN THE DEPARTMENT.

- 21 INTERVENTION SERVICES TO YOUTH WHO ARE EITHER CHEMICALLY DEPENDENT
- 22 OR HAVE BEEN IDENTIFIED BY SCHOOLS, JUVENILE JUSTICE AGENCIES. OR OTHER
- 23 SOURCES AS HAVING BEHAVIORAL OR MEDICAL PROBLEMS OR BOTH RELATED TO
- 24 TOBACCO ADDICTION, ILLEGAL USE OF ALCOHOL, OR ILLICIT USE OF OTHER DRUGS,
- 25 OR ANY OF THESE, INCLUDING THE YOUTH DUALLY DIAGNOSED WITH MENTAL
- 26 ILLNESS AND INVOLVED IN INCIDENTS OF VIOLENCE INCLUDING ATTEMPTS AT
- 27 SUICIDE; AND
- 28 (4) CREATE OR EXPAND COLLABORATIVE LINKS BETWEEN AND AMONG
- 29 SUBSTANCE ABUSE INTERVENTION AND TREATMENT PROGRAMS, THE CRIMINAL
- 30 JUSTICE SYSTEM, HISTORICALLY BLACK COLLEGES AND UNIVERSITIES, THE
- 31 DIVISION OF CORRECTION, SCHOOL SYSTEMS, HEALTH DEPARTMENTS, MEDICAL
- 32 FACILITIES, COMMUNITY BASED SOCIAL HEALTH AGENCIES, AND OTHER
- 33 INSTITUTIONS TO IMPROVE COST RECOVERY FROM THIRD PARTY PAYORS AND TO
- 34 ENHANCE THE COST BENEFIT AND COST EFFICIENCY OF THE LINKS FUNDED UNDER

- 36 (C) (1) THE GOVERNOR SHALL INCLUDE IN THE STATE BUDGET, BEGINNING
- 37 WITH FISCAL YEAR 2001, AT LEAST \$4 MILLION TO FUND THE PROGRAM AS
- 38 ESTABLISHED UNDER THIS SUBTITLE.

1 FUNDING FOR THE PROGRAM MAY BE PROVIDED THROUGH THE (2) 2 CIGARETTE RESTITUTION FUND. 3 13-1003. (A) THE DEPARTMENT SHALL DISTRIBUTE FUNDS FOR THE PROGRAM TO (1) 5 EACH LOCAL HEALTH DEPARTMENT OR A PERSON DESIGNATED BY THE 6 DEPARTMENT UNDER § 13-1006 OF THIS SUBTITLE, BASED ON A PROPORTIONATE 7 FUNDING FORMULA ESTABLISHED BY REGULATION. THE FUNDING FORMULA DEVELOPED BY THE DEPARTMENT MAY 9 TAKE INTO ACCOUNT THE FOLLOWING FACTORS FOR BALTIMORE CITY, BALTIMORE 10 COUNTY, PRINCE GEORGE'S COUNTY, AND THE REGION OF THE EASTERN SHORE: 11 (I) POPULATION; 12 (II)MINORITY POPULATION; RATES OF ADULTS AND ADOLESCENTS IN NEED OF SUBSTANCE 13 (III)14 ABUSE TREATMENT AND SERVICES; SUBSTANCE ABUSE TREATMENT AND SERVICES CURRENTLY 15 (IV) 16 AVAILABLE; AND ANY OTHER FACTOR THAT THE DEPARTMENT DETERMINES 17 (V) 18 WILL FURTHER THE PURPOSES OF THE PROGRAM. 19 BEFORE DISTRIBUTING MONEY UNDER THE PROGRAM, THE (B) (1) 20 DEPARTMENT SHALL PROVIDE FOR AN INDEPENDENT SURVEY TO DETERMINE FOR 21 BALTIMORE CITY, BALTIMORE COUNTY, PRINCE GEORGE'S COUNTY, AND THE REGION 22 OF THE EASTERN SHORE THE FACTORS LISTED IN SUBSECTION (A)(2) OF THIS 23 SECTION. THE SURVEY SHALL BE REPEATED AFTER THEIR PROGRAM HAS 24 (2) 25 BEEN IN EFFECT FOR 5 YEARS. 26 13-1004. - 15 GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY, THAT INCLUDES:

- 19 (2) AN ANALYSIS OF THE INITIATIVES' EFFECTIVENESS BASED ON THE
- 20 PERFORMANCE MEASURES DEVELOPED BY THE DEPARTMENT.

- 22 (A) THE DEPARTMENT MAY APPOINT A PERSON OTHER THAN THE LOCAL
- 23 HEALTH DEPARTMENT TO COORDINATE THE PROGRAM IN BALTIMORE COUNTY,
- 24 BALTIMORE CITY, PRINCE GEORGE'S COUNTY, AND THE REGION OF THE EASTERN
- 25 SHORE IF:
- 26 (1) THE LOCAL HEALTH DEPARTMENT IS UNWILLING TO PARTICIPATE
- 27 IN THE PROGRAM;
- 28 (2) THE LOCAL HEALTH DEPARTMENT LACKS SUFFICIENT STAFF OR
- 29 RESOURCES TO COORDINATE THE PROGRAM; OR

- 31 IMPLEMENTING SUBSTANCE ABUSE TREATMENT AND SERVICES THAT SATISFY
- 32 PERFORMANCE STANDARDS ESTABLISHED BY THE DEPARTMENT.
- 33 (B) IN CHOOSING A PERSON OTHER THAN A LOCAL HEALTH DEPARTMENT TO

- 36 (2) COORDINATE THE PROGRAM FROM WITHIN THE DEPARTMENT.
