CHAPTER 133

1 AN ACT concerning

2 **Maryland Veterans Commission - Membership**

3 FOR the purpose of adding a representative from the Maryland Coalition of the
4 Retired Enlisted Association to the Maryland Veterans Commission; and
5 generally relating to the Maryland Veterans Commission.

6 BY repealing and reenacting, with amendments,
7 Article - State Government
8 Section 9-907
9 Annotated Code of Maryland
10 (1999 Replacement Volume)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Article - State Government**

14 9-907.

15 (a) (1) The Commission consists of the following [28] 29 members:

1 (i) as an ex officio member, the Chairman of the Maryland
2 Veterans' Home Commission; and

3 (ii) [27] 28 members appointed by the Governor.

4 (2) Of the [27] 28 appointed members:

5 (i) 1 shall be appointed from each of the 8 congressional districts in
6 the State;

7 (ii) 1 shall be appointed from the State at large;

8 (iii) 1 shall be a representative of a women veterans organization in
9 the State; and

10 (iv) 1 shall be appointed from a list of individuals submitted to the
11 Governor by each of the following organizations:

- 12 1. the American Ex-Prisoners of War, Inc.;
- 13 2. the American Legion;
- 14 3. the Amvets;
- 15 4. the Catholic War Veterans;
- 16 5. the Disabled American Veterans;
- 17 6. the Fleet Reserve Association;
- 18 7. the Jewish War Veterans;
- 19 8. the Marine Corps League;
- 20 9. the Maryland Retired Officers Association;
- 21 10. the Military Order of the Purple Heart;
- 22 11. the Pearl Harbor Survivors Association;
- 23 12. the Polish Legion of American Veterans;
- 24 13. the Veterans of Foreign Wars;
- 25 14. the Veterans of World War I;
- 26 15. the Vietnam Veterans of America;
- 27 16. the Korean War Veterans Association, Inc.; [and]
- 28 17. the Black Veterans of All Wars, Inc.; AND
