CHAPTER 471

1 AN ACT concerning

2 **Security Systems Technicians - Denial of Registration**

3 FOR the purpose of requiring the Secretary of the State Police, before denying an  
4 applicant's registration as a security systems technician because that applicant  
5 pleaded guilty or nolo contendere or was convicted of a felony, theft offense, or  
6 crime of moral turpitude, to consider certain factors; and generally relating to  
7 the registration of security systems technicians.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That the Laws of Maryland read as follows:

1 **Article - Business Occupations and Professions**

2 18-3A-09.

3 Subject to the hearing provisions of § 18-3A-10 of this subtitle, the Secretary  
4 may deny registration to any applicant, reprimand any registrant, or suspend or  
5 revoke a registration if the applicant or registrant:

6 (1) fraudulently or deceptively obtains or attempts to obtain a  
7 registration for the applicant or registrant or for another;

8 (2) fraudulently or deceptively uses a registration;

9 (3) has a similar license or registration denied, suspended, or revoked in  
10 another jurisdiction;

11 (4) pleads guilty or nolo contendere to or is convicted of a felony, theft  
12 offense, or crime of moral turpitude;

13 (5) aids an individual in obtaining or attempting to obtain fraudulently  
14 or deceptively registration under this title;

15 (6) while not registered as a security systems technician and employed  
16 by or under contract with a security systems agency licensed under this title, willfully  
17 engages in personally providing security systems services;

18 (7) while not registered as a security systems technician and employed  
19 by or under contract with a security systems agency licensed under this title, willfully  
20 advertises as a security systems technician;

21 (8) willfully makes a false statement or misrepresentation in any  
22 renewal application or in any other document that the Secretary requires to be  
23 submitted; or

24 (9) violates any other provision of this title.

26 BEFORE THE SECRETARY DENIES THE REGISTRATION OF AN APPLICANT  
27 UNDER § 18-3A-09(4) OF THIS SUBTITLE, THE SECRETARY SHALL CONSIDER THE  
28 FOLLOWING FACTORS:

29 (1) THE LENGTH OF TIME THAT HAS PASSED SINCE THE APPLICANT  
30 PLEADED GUILTY OR NOLO CONTENDERE OR WAS CONVICTED OF THE FELONY,  
31 THEFT OFFENSE, OR CRIME OF MORAL TURPITUDE;

32 (2) WHETHER THE APPLICANT WAS A SECURITY SYSTEMS TECHNICIAN  
33 PRIOR TO THE REQUIREMENT OF REGISTRATION UNDER THIS SUBTITLE; AND

1           (3)       ANY EVIDENCE THAT THE APPLICANT HAS BEEN A GOOD CITIZEN  
2 SINCE THE APPLICANT PLEADED GUILTY OR NOLO CONTENDERE OR WAS  
3 CONVICTED OF THE FELONY, THEFT OFFENSE, OR CRIME OF MORAL TURPITUDE.

4       SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
5 October 1, 2000.
